PUBLIC COMMENT – Resident Doug Ceisner stated again that he witnessed Akron Police Officers at McDonalds as well as Rite Aid. He is concerned about the potential consequences of an accident outside of the Village. He also feels the same way about the School Resource Officer at Akron Central High School.

Resident Daniel Kowalik asked the Board about the new parking permit for Clinton Street and Church Street. Clerk-Treasurer Borchert stated the parking permits were implemented to create a reasonable way to efficiently contact residents who park on Clinton Street and Church Street on the side of Russell Park (which is considered Municipal parking) to arrange for snow removal events. The permit has no cost and the DPW would give at least a 24 hour notice to permitted drivers before any snow removal event. Village Attorney Shonn stated that a Traffic Order #23 will be voted on this evening in regards to the parking permits.

NEW BUSINESS

Sewer Moratorium – on the recommendation of the Water Wastewater Committee the Board agreed to extend the Sewer Moratorium for 50 units until June 30, 2015.

Background:

In June of 2014, the Village Board extended the sewer moratorium until December 31, 2014. Based upon the monthly operation reports provided by Camden Group, the Board finds that the Waste Water Treatment Plant is running well under its rated capacity. There is, however, significant infiltration in the collection system which requires a continuation of the moratorium at 50 equivalent household units. At this time more than 95% of the Village has had camera and smoke test evaluation. The continuation of the moratorium will allow the Village to complete testing and correction work.

RESOLUTION duly moved by Forrestel and seconded by Middaugh that the present moratorium as described by local law 2005-1 as amended is extended until June 30, 2015 be and hereby is approved.
