APPEARANCE – Kurt Schie along with his legal representation of Marc Romanowski and Greg Scholand came before the Board to present his new plan for rezoning 42 Jackson Street. Attorney Romanowski explained to the Board that Mr. Schie would like to rezone the 18.2 acres at 42 Jackson Street from a R-3 zone to a I-1 zone and also requested a special use permit, area variance and site plan approval. The proposed project involves adding one new building to the site and enlarging an existing building. Mr. Schie would continue to use the newly zoned property for his company, WoodMaxx Power Equipment Ltd., which handles assembly, storage and distribution of power equipment. Mr. Romanowski stated that the property does border I districts to the northeast and southwest and rezoning this property would connect these districts on the

west side of the Village. Mr. Romanowski explained that the property has a long history of industrial use and contains remnants of such use, which make it inappropriate for residential development. Mayor Patterson stated that the Village Board will direct the rezoning application back to the Village Planning Board for review. Village Attorney recommended the Village Board pass a resolution to name the Village of Akron SEQRA Lead Agency for the rezone and proposed development of 42 Jackson Street.
