WHEREAS, the State of New York by Chapter 6 of the 2007 Laws of the State of New York adopted Section 458-b of the Real Property Tax Law allowing local counties, cities, towns and villages by local law to provide a real estate exemption for Cold War Veterans who were described as a person, male or female, who served on active duty in the United States armed forces, during the period from September second, nineteen hundred forty-five to December twenty-sixth, nineteen hundred ninety-one, and was discharged or released there from under honorable conditions; and

WHEREAS, the Village Board of the Village of Akron has determined that it is in the best interest of the Village of Akron to provide such exemptions for Cold War Veterans residing in the Village of Akron

If the Village is removing snow on Main Street it should remove everyone's snow. 4) Mr. Ceisner is totally against hiring the Code Enforcement Officer currently working for the Town of Newstead who is from Pembroke. The Village Code Enforcement Officer should be from the Village. 5) Lastly, Mr. Ceisner has located several unlicensed vehicles located on the following streets: East Avenue, Knapp Road, Cedar Street, Main Street, and Crittenden Road. Mayor Patterson thanked Mr. Ceisner for his comments.
