RESOLUTION, duly moved by Forrestel and seconded by Capan to adopt the Local Law No. 2 for 2009. A local law amending Chapter 122 of the Code of the Village of Akron with regard to use of a mechanical clamp device for sewer construction.

Be it enacted by the Board of Trustees of the Village of Akron as follows:

SECTION 1: The Village Board has been under order of the New York State Dept of Environment Conservation to reduce the amount of water infiltration in the waste water treatment system. The Board finds that a significant amount of infiltration can enter the system

where underground joints between vents, risers, and cleanouts separate from the homeowner's sewer lateral. In order to reduce the chance of the separation of joints, the Board will specify a clamping device at such joints.

SECTION 2: Chapter 122-12 is amended by adding Subparagraph 4 to Chapter 122-12 A. of the Code of the Village of Akron as follows

Vents, risers, and cleanouts when connected to newly constructed or reconstructed sewer laterals will have a mechanical clamping device at the joint. Such clamp will be in accordance with the specifications approved by the Village Superintendent of Public Works.

SECTION 3: This law shall take effect upon filing with the Secretary of State of the State of New York.

Clerk-Treasurer Borchert stated the Police usually are in service 20 hours per day between the hours of 6:00 a.m. to 2:00 a.m. everyday. Mr. Ceisner also stated that there is a vehicle parked in front of 38 Main Street almost everyday from 8:30 a.m. to 4:30 p.m. and wondered why it is allowed to be parked there in a 2 hour parking zone. He questioned the Board on how much cancer is in the Akron water. Trustee Kaufman, Attorney Shonn as well as VRI Environmental Services Representative Ken Scherrieble stated that the water is under strict guidelines by the State and is monitored accordingly. Lastly he stated that the Batavia governments will be consolidating within the next three years and wondered when the Village of Akron and the Town of Newstead will do the same. Mr. Ceisner would like to see the break down of the cost to run the Village on the website.
