Stormwater Outlet to Murder Creek/Replacement Project – Supt. Kowalik reported that a bond has been posted and that the vegetation is growing around the crib wall as expected.

## <u>Departments</u>

VRI — Written report for May 2005 submitted. VRI Representative Ken Scherrieble highlighted the following: 1) filters were re-built and are performing well, but the amount of backwashing is still immense; 2) costs for the filter rehab project exceeded initial cost estimates by approximately \$1,400 for a total cost of \$8,877.18; 3) I&I work continues; and 4) Industrial Pre-treatment Program continues. Village Attorney Daniel D. Shonn will be working with Supt. Kowalik and Ken Scherrieble to review and adjust language in draft ordinance. Attorney Shonn asked about the status of the moratorium in light of progress at the sewer plant and Ken Scherrieble noted that the NYSDEC is awaiting the next batch of data results before considering whether the moratorium should be extended or lifted.

BLDG. INSPECTOR – Donnal D. Folger reported that he has been researching fence and temporary structures ordinances. Also, he reported that 11 vehicles on 10 properties within the Village remain stored in violation of property maintenance law and could be subject to public hearing before the Board following certified mailing of Violation Notices.
