Additional Information:

1. All plumbing and drainage work must be performed by a plumber who holds a valid license with the Village of Akron.
2. All road cuts on Village roads and streets require prior authorization from the Department of Public Works Supervisor at 542-2680.
3. All road cuts on Village roads and streets must be paved immediately and will be inspected by the Department of Public Works. Where cold patch asphalt is used to repair a road cut, it is the contractor's responsibility to permanently repair the road cut with appropriate paving materials when said materials are available. Permanent paving for road cuts made during winter months must be completed by June 1st or a penalty shall be incurred.
4. For all road cuts on State or County roads, it is the contractor's responsibility to obtain appropriate permits from relevant agencies. Road cuts on State or County roads must be repaired to State or County specifications. This permit does not include any privilege of encroachment in, over, under, or upon any city street or right-of-way.
5. Bubblers are allowed only when there is no storm sewer available within 100 ft. Bubblers will be inspected and approved by the Code Enforcement Officer and Department of Public Works.
6. Work conducted pursuant to this permit must be visually inspected by the Code Enforcement Officer and must confirm to New York State Uniform Fire Prevention and Building Code, as well as all applicable rules, regulations, Codes, and Ordinances of the Village of Akron.
7. In the event that it becomes necessary to deviate significantly from plans filed with this permit, or if the scope of work conducted under this permit is changed, the Building Department must be notified immediately.
8. If a Certificate of Occupancy is required, the structure shall not be occupied until said Certificate has been issued.

Please provide a copy of your Liability, Workers Compensation, and where applicable, Workers Compensation Exemption form CE-200. Please note this is required prior to any work being performed.

**All permits expire after one year from date of approval with a 6 month extension available with a fee up to original amount not to exceed \$50.00.

All permits are granted subject to requirements of the Village of Akron Zoning ordinances and the New York State Uniform Fire Prevention and Building Code- a copy of which may be obtained at the Village Clerk's Office or on the Village website at www.erie.gov/akron
