2024 -2025 Village of Akron Budget - Due to the reevaluation done in 2023, the tax rate for the Village had to be adjusted accordingly to remain consistent with the previous taxes charged to the residents of the Village of Akron. With the increase in wages, materials and other expenses that comprise the services provided to our residents, a gap in the budget was created of a \$352,805 surplus. In order to balance the budget while maintaining the level of service that is provided, the tax rate was established at \$4.80 per thousand. Comparatively, the tax rate for the 2023 property taxes in the Village was \$6.08. In an effort to not create a shortfall of the benefits that are provided, the village has diligently worked to create a balanced and fair budget that will allow for the current level of productivity to continue.
