### **New Business**

Zoladz rezone. Mark Tufillaro, construction manager for Zoladz, presented a drawing that represents all 3 properties that Zoladz owns on Two Road and Broadway that they wish to combine into a single parcel. A formal site plan will need to be presented to the Planning Board before the 2 cold storage facilities could be built there. As a first step, the 2 right-most parcels need to rezoned. They are currently restricted commercial and need to be rezoned to C2. The total property would then match what's there on the corner and behind which is currently zoned C2. Matt Malecki moved to recommend that the Town Board rezone the parcels to C2, Bob Meyer seconded. Unanimous. Carried.
