Approval of previous minutes

Minutes of the January 9th meeting, as amended below were approved; motion made by Ron Gardner, second by Frank Alteri. Carried. Unanimous.

Mike Fleming wanted the amended language to the January minutes revised once again. He stated that the appointments made in 2016 were never voted on per Ralph Witt. Chairman Dewitt and Councilman Adamski both stated that the standard process is to vote on all appointments and that this was followed at that time and has always been followed by the Town Board.

Communications

Letter from Erie County Dept of Health. This letter detailed changes around water and sewer hookups installed and maintained by HOAs as responsible entities for the operation and maintenance of non-municipal waterlines within realty subdivisions. The changed regulations conform to NYS requirements.

New Business

Cold war veterans tax exemption. The Town wants to add the exemption to be consistent with what is being done by Erie County. Frank Altieri moved, seconded by Ron Gardner, to recommend the adoption of the law to the Town Board with the stipulation that a 'cold war veteran' be defined in the language of the code and changes be made to the wording in SECTION 4 B to capitalize the U.S. departments that provide the service. Carried. Unanimous.

Unfinished business

Mike Fleming had a question on the Metz subdivision. CEO Snyder explained that what the Planning Board recommended is what the Town is acting on, which was the subdivision of one lot. Councilman

Adamski stated that Mike Fleming contacted another government entity (Jennifer Delaney) asking about the fill to be used in the property. Councilman Adamski was concerned that Mr. Fleming was over stepping his authority as a Planning Board member and creating potential liability for the Town. Mike Fleming stated that he did call to ask about fill. He also said that he followed the trucks after they dumped and the fill came out of the building next to Republic Steel. Frank Alteri did some research and provided documentation from the contractor stating that there was no contaminated soil on that property. Chairman Dewitt reiterated that the Planning Board is an advisory body and not an enforcement body.
