# **Approval of previous minutes**

Mike Fleming requested clarification on certain items included in the minutes of the December 13<sup>th</sup> meeting focusing on the Sled Shop site plan and the proposed addition to the Roberts property on Broadway. After discussion and clarifications provided, the minutes were approved as written, motion by Randy Crist, second by Bob Meyer. Unanimously approved.

#### **New Business**

- 12975 Genesee Street. Minor subdivision is being proposed because the property owner wants to build a house on the lot in the Spring with a shop attached to it that would potentially be used as a cider press. The proposed plan complies with the Town's Master Plan. Duane Conners made a motion to approve that the subdivision be recommended to the Town Board; Bob Meyer seconded the motion and it was carried unanimously.
- Site Plan Zoeller Road Cold Storage. Bob Labenski acted as representative for the owner who could not attend. He presented the site plan showing the proposed storage building (pole barn) next to the existing building as well as accommodations proposed for additional drainage. Neighboring residents will not be impacted because there is no need for a sign or additional lighting, and the owner also plans on cleaning up the back area of the property. Septic system was already approved and no utilities are planned for the new building. The Town Engineer reviewed the plan and provided additional items for consideration which the Planning Board discussed. The proposed plan complies

with the Town's Master Plan. Duane Conners made a motion to recommend the site plan to the Town Board; Mike Fleming seconded the motion and it was carried unanimously.
