Approval of previous minutes

Minutes of the December 12th meeting, as amended below were approved; motion by Duane Conners, second by Ron Gardner. Unanimous.

Mike Fleming wanted a correction made to the minutes. He questioned why only certain sections of his comments were included and why the minutes were made public. Chairman Dewitt referred Mr. Fleming to Supervisor Savage for those details. Mr. Fleming further explained that the focus of his comments was on the picking of the members and reiterated that the last openings were never advertised in the paper. In the past, the board would have been asked for feedback on candidates but that didn't happen with the recent appointments. The current candidates didn't get submitted before being appointed so the rest of the board didn't have their say. Mr. Fleming stated that Supervisor Savage didn't rely on the Town Board but acted like the process were a dictatorship. Dean Adamski stated that there was an ad in the paper when he was appointed and the rest of the board confirmed that they had seen it posted.

Metz minor subdivision – North Road. Mr. Metz is looking to subdivide to accommodate the building that he's proposing. CEO Snyder provided the proper documentation and the building permit has already been issued, and the proposal complies with the Town Code. Duane Connors explained that Erie County already had recorded this subdivision in its records as the work was already underway on the new house. Joe Kraus commented from the floor that the foundation shouldn't be on that property because you cannot

have 2 houses on a single lot, and stated that his prior dealings on another lot led to him losing money because Erie County would not approve it and this situation seems to be the same to him. The Planning Board agrees that the subdivision conforms to the Town's Master Plan. Matt Malecki motioned to approve recommendation of the subdivision to the Town Board; Duane Conners seconded. Unanimous.
