Prior to discussing the expansion, he stated that there are some open items that need to get completed before a final certificate of occupancy can be granted on the current location. Mr. Baccari then provided an overview of the proposal for more bays and another separate building. The Planning Board provided comments on several elements that need to be defined and documented on the site plan, including detention pond, septic, drainage, fencing, paving, utilities, garbage disposal, etc. In general, the Planning Board felt the concept was fine and that the focus should now be on the infrastructure details. Mr. Baccari will work with Town Engineer Metzger to ensure that the site plan complies with the Town's Master Plan and hopes to provide a final site plan that contains all elements at the next Planning in August.
