New Business

Minor subdivision on Genesee Street. CEO Snyder gave a brief overview of the property and plan. The property owner wants to build a house on the lot in the Spring. Bob Meyer moved that the discussion get tabled until the next meeting so that the material could be better reviewed; seconded by Don Stoffel; carried unanimously.

Unfinished business

- Moore Site Plan (Sled Shop property) – Broadway. Site plan was submitted and reviewed by the Planning Board using the Site Plan Review checklist. The lack of utilities drawn in is not an issue because the same owner owns the adjacent house from where the utilities will be provided. The Planning Board discussed his using a vehicle as a sign which they do not like but it is a registered, moveable trailer that does comply with the letter of the law. Items that need modification are parking

lot cross section (asphalt paved area), driveway permit, and DOT permit need to be obtained and provided to CEO Snyder. Duane Connors made a motion to recommend approval of the site plan to the Town Board contingent on DOT approval of the driveway, paved parking lot and the Town Engineer's final approval; seconded by Dean Adamski; carried unanimously.

- Mazz Auto Site Plan Broadway. No new information was presented.
- Sludge storage No new information was presented.
