- **1. General Code** LoriAnn Shura from General Code made a presentation regarding the possible update of our code book which has been updated about 95x's since it was produced in 1963. The updated book would include a new index page, table of contents and larger format of 8.5 x11. The company would do an organizational analysis, editorial/legal review and final editing before a draft is made up. This is a three year process. The update would also include eCode 360 which is the online version of the code book. This online version would be available for anybody to access.
- **2. Community Center signage** Park Superintendent Andy Sojka spoke about a quote for new aluminum signage for the outside of the Community Center. Attorney Strong will prepare a resolution to approve the purchase of the new signage at the next Town Board meeting. Andy Sojka also spoke about the quote for the visual inspection of the asbestos abatement on the exterior walls.
- **3. Snow blower for Town Hall** Park Superintendent Sojka spoke about the quote that he got for the new snow blower for use at the Town Hall. Attorney Strong will prepare a resolution to purchase said snow blower at the next Town Hall meeting.
- **4. Soccer Tournament** A representative from the Alden Soccer Club made a presentation asking for permission from the Alden Town Board to approve the use of the soccer fields at the Robert O. Smith Park next spring.
- **5. Snyder sub-division lead agency -** Attorney Strong will prepare a resolution to approve Lead Agency for the Snyder sub-division at the next Town Board meeting.
- **6. H.O.P. renewal for Mary Wojnar -** There will be a motion to approve the H.O.P. renewal at the next Town Board meeting.

- **7. Road repairs** Highway Superintendent Gary Wagner spoke about the need of funds for road repairs. Gary Wagner asked if he could take a seasonal highway employee and make him full time. Attorney Strong will prepare a resolution for the full time Highway employee at the next Town Board meeting.
- **8. CDBG grant -** Attorney Strong will prepare a resolution to apply for the CDBG grant for the master plan update for the code book update.

- ~ Supervisor Milligan and Colleen Rogers spoke about the Holiday Toy Assistance program. This is a program designed to provide holiday gifts for needy families with children ages 0-17. Registration will be at the Alden Community Center on October 28 from 10:00 AM to 3:00 PM.
