Matt Herdzik/S. Woodside Drive questioned the impact of the decline in population that he read about in Sunday's paper on the Fire companies. He questioned if the budget includes the service award program? Supervisor Savage responded that it did. Mr. Herdzik questioned whether there was a separate fund for that program. Supervisor Savage said that it is a separate line item but is paid out of the special fire protection budget. He wondered if there was a reserve fund put aside to guarantee down the road that they will get a retirement award. It is administered by a company who tells the Town what they have to put into it each year. It is a 10 year certain; we are obligated that we have to pay them. Mr. Herdzik questioned the amount of the reward program received. Supervisor Savage believed it to be approximately a maximum of \$400.00. Points must be maintained. The Town gives the money to a company to manage the funds and disburse them. The management fee has gone from \$3500.00/year in 2009 to \$5300.00 this year, a 25% increase. Mr. Herdzik is concerned that with the population is dropping there will be a need for volunteer firemen. He notices signs out looking for volunteers at the fire companies. Down the road we could be in trouble for fire protection. He feels that \$400.00 is an insult to firefighters that have been in service for 20 years. Supervisor Savage said it is not meant to be a regular pension. It is a reward for being a volunteer. He feels if they could give richer rewards to people perhaps they could get more people to become volunteers. Supervisor Savage said there are four new members that will be approved for Millgrove Volunteer Fire Dept. tonight. They are a dedicated bunch of people and we are fortunate to have them. They take time away from their families to answer calls in the community. They are very much appreciated. Mr. Herdzik stated whatever we can do for those guys...do it.
