He was wondering if it would be possible to get service with Verizon's FiOs digital service. A member of the Supervisor's office contacted Verizon and they said that there is no plan for expansion in our area at this time but we are welcome to call back for updates.

Attorney Strong:

She has now received from the Marilla Car Show in Alden all of their insurance and they have met all of the Towns requirements at this time.

Councilwoman Riddoch:

She has spoken with Alden Pools and Play regarding the installation of the replacement playground which is scheduled for July 14th unless it needs to be rescheduled if the area is not ready.

Supervisor Milligan:

The monthly report was received from the Town Clerk/Receiver of Taxes and that she has received \$5,021,493.36 in fees and moneys for the payment of taxes since the first of the year. A letter was received from IDA from Erie County and it stated they do well with their IDA's and it has a breakdown of what the State reported on.

The bill to rename the U.S. Post Office in Alden, New York after Army Sergeant Brett Gornewicz has passed.
