WHEREAS, the Alden Town Board has received a request from the Parks Supervisor to purchase a new snow blower the estimated cost of which is less than \$2,000.00 but greater than \$500.00;

WHEREAS, the Procurement Policy & Procedure Guidelines ("Guidelines") of the Town of Alden state that the Town must obtain written quotes from at least two (2) vendors;

WHEREAS, requests for proposals were made to two (2) vendors and quotes were received as follows:

The highest bidder is Ken's Sales and Service at \$1,206.15 and, The lowest bidder is Woodcutters Headquarters Inc. at \$885.97;

WHEREAS, Woodcutters Headquarters Inc. is the lowest responsible bidder; and

WHEREAS, The Town Board after full and careful review and consideration of the request finds that it is in the public interest to authorize the purchase of the above described snow blower;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS, THAT:

- 1. The Town Board approves the purchase of a snow blower from Woodcutters Headquarters, Inc. for \$885.97;
- 2. The Parks Supervisor of the Town of Alden is authorized to sign any and all necessary documents to effectuate this purchase; and
- 3. This resolution shall take effect immediately.

On the Question: Supervisor Milligan believed it was discussed at the last Work Session that we were not going to order this until next year. Councilwoman Riddoch said the price and availability could not be guaranteed for next year. If a storm should occur between now and the next couple of meetings, they would not have the equipment for cleanup. Supervisor Milligan also questioned why quotes were not received from local dealers. He feels that the Town should buy local whenever possible. Councilwoman Riddoch will check with Park Supt. Sojka to see why quotes were not done locally.

THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR MILLIGAN, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMAN WITT, TO WIT;

WHEREAS, The Town of Alden Building Inspector on October 27, 2014 made a report to the Alden Town Board that the building located at 11133 Broadway (on the Alaura Street Side) is so dangerous and unsafe as defined by Chapter 7A of the Alden Town Code; the building is so dilapidated, decayed, unsafe and unsanitary, that it utterly fails to provide the amenities essential to decent living so that they are unfit for human habitation.

WHEREAS, The Building Inspector has determined that the building: cannot be reasonably

repaired; is dangerous to the health, morals, safety and general welfare; and is more than 50% damaged, decayed and deteriorated from its original structure; and that said building is a public nuisance.

WHEREAS, the Building Inspector has properly notified the owner and the owner's attorney, and all other persons having an interest in said building (none) that the building has been found be to dangerous, unsafe, and a public nuisance and has given notice that the building must be repaired or demolished within thirty (30) days.

WHEREAS, the Building Inspector has posted notice of the Building being dangerous, unsafe, and a public nuisance on the property.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT:

- 1. That a Hearing be held before the Alden Town Board on January 5, 2015 at 7:20 PM at the Alden Town Hall, 3311 Wende Road, Alden, New York on the report made by the Building Inspector and to determine if the building is dangerous, unsafe and a public nuisance;
- 2. That the necessary Notice of Hearing, as required by Section 7A-6(B) of the Alden Town Code be published in the Alden Advertiser, the official newspaper of the Town of Alden, and be posted on the Town Bulletin Board, and mailed to the property owner and other parties having an interest in the property, which Notice shall be in the form attached hereto and made a part hereof; and
 - 3. This Resolution shall take effect immediately.
