The Waiss's said this is a beginning step for them and if it grew they would go to an area that is not residential but commercial to open a store. Councilwoman Riddoch said that the whole purpose of an H.O.P. to start out in their home and hopefully grow to a business. They are not against business at all, they would love to see the business grow and open on a commercial area in Alden.
