WHEREAS, the Town of Alden has received Federal Community Development Funds to Rehabilitate the Bathroom Facilities in the Alden Town Park ("the Project");

WHEREAS, the Town of Alden, after properly letting the bid, hired Nussbaumer & Clarke, Inc. to design the Project and Nussbaumer & Clarke has designed the Project;

WHEREAS, pursuant to the Procurement Policy & Procedure Guidelines of the Town of

Alden and General Municipal Law section 103, the Town of Alden has properly solicited and received bids for the construction of the Project and bids were received as follows:

The highest bidder is Hadala Construction at \$125,522.00;

The second highest bidder is MKS Plumbing at \$124,875.00;

The third highest bidder is S&W Contracting of WNY at \$75,000.00;

The fourth highest bidder is Miller Enterprises at \$72,094.00;

The fifth highest bidder is Patrick Construction at \$70,421.10;

The sixth highest bidder is Ledge Creek Development at \$61,080.00; and

The lowest bidder is Wilsandra Construction at \$60,985.00;

WHEREAS, the bids submitted by S&W Contracting of WNY and by Patrick Development are incomplete and hereby both rejected; and

WHEREAS, Wilsandra Construction is deemed the lowest responsible bidder.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS, THAT:

- 1. Town Board approves the signing of an Agreement for Construction Services, in substantially the form attached to the RFP, with Wilsandra Construction for a total cost of \$60,985.00;
- 2. Ronald L. Smith, as Supervisor of the Town of Alden, is hereby authorized and directed to sign said Agreement; and
- 3. This Resolution shall take effect immediately.
