Supervisor Savage explained the different areas that are covered by the Preliminary Budget. Tom Malecki, Auditor passed out a pie chart on the Budget process and where the allocated funds go.

BUSINESS FROM THE FLOOR

Supervisor Savage had the students from Alden Central School introduce themselves and tell what class they were there for.

Omar Ali, North Rd. came to the Board to ask for help with a problem he is having with the Alden/Aurora Gas Company. In the past, he had been receiving free gas in accordance with a gas well they installed on his property. He has been in Court and now they want to remove the well from his property. Supervisor Savage asked that he call the office tomorrow with further information.

A student from Alden Central School wanted to know the status on the ice rink. Supervisor Savage said that the surface is absorbing the water and it is not retaining the water enough to create a surface for skating. It may be sealed next year. He will check with Andy Sojka.

COMMUNICATIONS

Supervisor Savage:

- 1. A letter was received from Commissioner Loffredo regarding the interim snowplowing contract with the County. The Town negotiation committee made up of Supervisors, rejected the offer. They are now offering a rate increase of 3% for 2017 and an additional rate of 2-1/2% for 2018. The Association of Erie County Government would like us to reject this. It will be a Board decision. This will be discussed at the Work Session. Hwy. Supt. Wagner said that this will also be discussed at the upcoming Highway Supt. meeting.
- 2. The Village of Alden Board Minutes was received from their September 22, 2016 meeting.
- **3.** A signed agreement was received back from Newstead regarding the sharing of the Assessor and assessing services between the Town of Newstead and the Town of Alden.
- **4.** A resignation letter was received from Barbara Weber, Deputy Town Clerk.

- **5.** A letter was received from Metzger Civil Engineering regarding Adam Mazz Sales.
- **6.** The minutes were received from the October 11, 2016 Planning Board meeting.
- 7. February 5th, Supervisor Savage e -mailed the acting Superintendent at Wende regarding the four lamp standard that lights the overpass being repaired. The acting Supt. reported wiring problems and a 1612 was turned into Albany for the repair. To date it has not been repaired. The new Supt. was asked what the status of the 1612 (request to Albany) was and it was never submitted. He assured Supv. Savage it will now be submitted and become a priority, which could take a while. Supervisor Savage was disappointed as the visibility in the winter becomes limited on the overpass.
- **8.** A letter was received from Erie County Water Authority with amounts pass due. Assessor Sivecz will put those on the taxes.
- **9.** An e-mail was received from Joe and Cheryl Guido regarding the ZBA Hearing for Henrys/ Bonnie Lake Dr. on September 27, 2016. They are not in favor of them having chickens for any reason. Supervisor Savage advised them that there will be a Public Hearing on the proposed new local law that would allow 6 hen chickens and they are welcome to come express their concerns.
- **10.** A certificate of Recycling was received from SunnKing regarding the electronic waste picked up at the Town Hall. There was 5859 lbs. picked up.
