Usually the bank will try to sell it to recoup some of their money, but not in this case. The garage will be demolished and the area cleaned up.

WHEREAS, the Town Board of the Town of Alden is considering an application, by Powerhouse Services ("the Applicant") for site plan approval of a 8,000 square foot service building and 13,175 square feet of paving at 12080 Walden Avenue, in the Town of Alden, further identified by SBL 96.00-3-41 (The "Proposed Action");

WHEREAS, the Town Board of the Town of Alden has determined that the Proposed Action is an Unlisted Action under SEQRA but has determined that it is in the public interest to conduct a coordinated review and has notified the involved agencies;

WHEREAS, the Town of Board of the Town of Alden believes that the Town of Alden is: the agency primarily responsible for undertaking decisions as to site plan review; is the agency with the broadest governmental powers for investigating the impact of the proposed action; has the greatest capacity for providing the most thorough environmental assessment of the proposed action; and is the most local agent with permitting authority;

WHEREAS, the Town of Alden has provided notice to Erie County Planning as required under Section 239-m of the General Municipal Law and a "no recommendation" was received;

WHEREAS, the New York State Environmental Quality Review Act requires the Town of Alden to determine the Lead Agency status and the Lead Agency making a SEQR determination;

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law and the Code of the Town of Alden, Chapter 9D, the Applicant has prepared the Environmental Assessment Form, which is now on file with the Town Board and the Town's SEQR Intake Officer; and

WHEREAS, the Town of Alden Planning Board has recommended the approval of the site plan contingent upon the Town Engineer's concerns being addressed to the satisfaction of the Town Engineer.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT:

- 1. The Town Board has determined that the Proposed Action is an Unlisted Action under SEQRA and that a proper review has been conducted;
- 2. The Town Board has determined that the Town of Alden should be the lead agency for all environmental review of the Proposed Action;
- 3.  - C. Erie County Health Department septic system approval;
- D. The water service and septic system must be separated by a minimum of ten (10) feet and depicted accordingly on the site plan;

- E. A note being added to the site plan indicating that, "In the sole discretion of the Town of Alden, should it be determined by the Town that additional parking is required on the subject property to come into compliance with zoning ordinance requirements, the Owner shall construct same as shown on this plan as land banked parking when ordered by the Town;"
- F. The site plan being amended to show landscaping on the west side and the east side of the building as required by the Town Code;
- G. Once the building is built, the Town Board will assess the Applicant's request to allow the natural vegetation at the rear of the property to be considered ample buffering to the residentially zoned land behind the property;
