## **BUSINESS FROM THE FLOOR**

Scot Weinreber from 11127 Alaura Dr. asked if he could receive via e mail the full engineering report for Sewer District #2, as opposed to the one they had. It did not seem to be the full report. Attorney Strong said she has the files for the full report digitally. There was a discussion on the tie ins and maintenance costs. Supervisor Savage said he will be setting up an informational meeting. The Town is putting in for a grant and low cost funding, but Supervisor Savage is doubtful we will receive it but we will try. The application is due by June 23<sup>rd</sup>. The SEQR will be adopted next meeting, along with a public hearing on the bonding. This will give us the power to go out and bond the project no matter what. The plant is going to fail and a portable system will have to be brought in and paid for until the new system is designed and built. The money will be going right down the sewer with no benefits. There is an eight inch bow in the steel wall from water pressure. Supervisor Savage had received the first study in August of last year and asked for the cheapest system as possible. It came back with a replacement of a package plant built next to the existing plant until the new plant was built. The cost was \$970,000.00. The DEC (Richard Rink) and Eng. Metzger had indicated that the DEC was approving sand filter beds for some municipal purposes. Supervisor Savage asked them to revise their study including that as a possibility and it became their recommendation. Eng. Metzger & Supv. Savage went to Fillmore, New York at the request of Richard Rink from the DEC to look at their system. It is a sand filter bed but they use small pea gravel in three separate beds and it's an open bed. If you have to change the media, you don't have to dig it up making it easier to maintain. So that's what he is pushing for. It has PVC pipes that go across the beds and is forced recycling. A community septic tank would be where the pipe comes in by the driveway and that would be gravity, it would have to be pumped to the field. Some of the things they recommended, like chopper pumps was not recommended by our Engineer. What Richard Rink said he would like us to have is a chlorinator and you need another chemical to take the chlorine out of it as a second process. If you chlorinate, you have to test daily. The other idea about using a sand filter bed as opposed to a regular package plant is that you wouldn't need a certified plant operator daily. It is a pretty substantial cost approximately \$25,000.00 a year. Letters will be sent out to homeowners. Scot Weinreber works at University of Buffalo and he would like them to review the engineering report. He will leave his e mail and the files will be sent to him. Mr. Weinreber also questioned the status of the former Alden Scientific Building. CEO Snyder said notices have been sent out and he is in and out of Court with the owner. The Court can impose fines. He continues to follow up.

Matt Herdzik, S. Woodside Drive voiced his concern over the trenches that were dug for drainage ditches on Townline Rd. by the new houses. They are like ravines and pose a safety factor. Townline is a County Road and they would have to be notified if guard rails are needed. Supervisor Savage will take a look at the area.

Ron Rebmann, Broadway was concerned with the Railroad Crossing in the back properties that will be closed, this will affect the snowmobilers. Supervisor Savage contacted Marilla Snow-Mob and told them to contact Norfolk Southern right away. The sign was posted on April 7th and you had 60 days to notify if you want it kept in. Ron had a picture of the mileage marker; Supervisor Savage will contact Senator Gallivan's office to see if there is something they can do. Accessibility to the farms will also be affected.
