WHEREAS, the Alden Town Board has received a request from Parks Supervisor Andy Sojka to purchase 40 cubic yards of New York State Certified Playground Mulch for the various Town Parks for the 2016 summer season the estimated cost of which less than \$2,000.01 but greater than \$500.00;

WHEREAS, the Procurement Policy & Procedure Guidelines ("Guidelines") of the Town of Alden state that the Town must prepare a request for proposal and then obtain written quotes from at least two (2) vendors, except in the case of a sole source provider where multiple quotes are not required;

WHEREAS, Attica Package Company, Inc. is the only mulch provider who sells New York State Certified Playground Mulch; and

WHEREAS, The Town Board after full and careful review and consideration of the request finds that it is in the public interest to authorize the purchase of the above described mulch.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS, THAT:

- 1. The Town Board approves the purchase of 40 cubic yards of New York State Certified Playground Mulch from Attica Package the sole source provider, to be delivered to the Town of Alden (delivery is free) at a total cost of \$720.00 (\$18.00 per cubic yard);

WHEREAS, the Yellow Dot Program can be also be utilized at a residence by placing the decal on an entry door(s) of a dwelling as to alert first responders that important medical information for one or more of the residents, within the dwelling, can be located in a clear plastic bag in the freezer compartment of the refrigerator;

WHEREAS, Erie County Sheriff Timothy B. Howard and the Sheriff's Office has staff and resources dedicated to raising the awareness of the Yellow Dot program in the towns, villages and communities throughout Erie County; and

WHEREAS, the Sheriff's Office has encountered situations where a Yellow Dot decal has been helpful to first responders at the scene of an incident and contributed to the fast and proper triage of a victim.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT:

- 1. The Town of Alden does hereby recognize the live-saving potential of the Yellow Dot program;
- 2. The Alden Town Board declares the Town of Alden as a Yellow Dot community and encourages all citizens to sign-up for and participate in the live-saving program Yellow Dot Program; and

WHEREAS, The Town Board after full and careful review and consideration of the request finds that it is in the public interest to authorize the purchase.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS, THAT:

- 1. The Town Board approves the purchase a sports field line striper from Pioneer Athletics, the second lowest bidder at a total cost of \$3,450.00;
