COMMUNICATIONS

Supervisor Milligan received communications from Rural Metro for the Month of December, they had a 96.2% performance, gave a copy of Alternative Care/Meals on Wheels annual report from last year to Board members, they have prepared over 10,000 meals for the year, communications from Sue Johnson; Senator Gallivan's office re reforming Medicaid.

Supervisor Milligan moved and Councilwoman Riddoch seconded the Motion to approve the renewal of the Haulers Permit for Waste Management for the Year 2012. Unanimously Carried.

Councilwoman Riddoch moved and Councilman Weber seconded the Motion to approve the renewal of a Home Occupation Permit for Edward Sisson Jr./11323 Broadway/Glass Block Windows. Unanimously Carried.

Supervisor Milligan moved and Councilwoman Riddoch seconded the Motion to refer the Home Occupation Permit application of Ken and Sue Tomporowski/11230 Westwood Rd./Sale of refurbished antique furniture and handmade items to the Planning Board for review and recommendation. Unanimously Carried.

Councilwoman Riddoch moved and Councilman Weber seconded the Motion to allow CEO Snyder to attend the annual Niagara Frontier Building Officials Education Conference on January 23-25th, at reasonable Town expense, at the Millennium Hotel in Cheektowaga. Unanimously Carried.

Councilman Weber moved and Councilwoman Riddoch seconded the Motion to allow TOPS/Chapter 150 to use the Community Center on Tuesdays/4:30 PM-5:30 PM for the Year 2012. ON THE QUESTION: COUNCILMAN WEBER ASKED WHAT TOPS WAS? COUNCILWOMAN RIDDOCH RESPONDED: TAKE OFF POUNDS SENSIBLY. Unanimously Carried.

Supervisor Milligan moved and Councilman Weber seconded the Motion to allow the Alden Hook & Ladder Fire Co., Inc. to use the Alden Town Park for its "Summer Carnival" from June 21-23, 2012, contingent upon the Town's receipt of insurance prior to the event from: The Village of Alden; Alden Hook & Ladder fire Co., Inc. and all vendors at the event (including but not limited to the ride operator and fireworks display company) and contingent upon the Village of Alden and the Alden Hook & Ladder Fire Co. giving an indemnification agreement to the Town of Alden prior to the event; and contingent upon the Town Park Renovations being completed. Unanimously Carried.

Councilwoman Riddoch moved and Councilman Weber seconded the Motion to allow the Alden Hook & Ladder Fire Co., Inc. to use the Alden Town Park for its "Dollars for Scholars 5-K Run – Post race party of Friday, June 8, 2012 contingent upon the Town Park renovations being completed.

Councilman Weber moved and Councilwoman Riddoch seconded the Motion to allow the Alden Hook & Ladder Fire Co., Inc. to use the Alden Town Park for its "Summer Steak Outing" on Thursday, August 16, 2012 contingent upon the Town Park renovations being completed. Unanimously Carried.

Town Clerk Ralph Witt reported that the tax bills have all been mailed out.

Councilwoman Riddoch reported that we are preparing the ice rink for Winterfest, weather permitting. The cabinets are in at the Community Center. The bathroom project in the Town Park is almost complete. She would like the personnel policy update on the Work Session.

Engineer Metzger reported on the following:

<u>Boiler</u>: Trying to get things wrapped up and finish the paperwork for NYSERTA.

<u>Shared Municipal Services Grant</u>: Paperwork needs to be completed to close out this grant.

<u>Erie County Water Authority taking over maintenance</u>: Trying to figure out which hydrants are owned jointly by Erie County and the Town, he will be looking into this. He will over the draft agreement from Erie County Water Authority.

<u>Revised Flood Plain Maps</u>: Waiting for DEC and FEMA to finalize the maps so they can be adopted. Have been delayed.

Planning Board Member Don Stoffel questioned that if Erie County Water Authority took over the maintenance, would this affect Water District #5. Engineer Metzger said it would not.

Supervisor Milligan asked Dog Control Officer Weglarski how the dog enumeration is going, he is about 1/6 done. The work on the Comprehensive Plan will continue. He would like to put memorials to Robert Rademacher/ Alden Seniors on the Work Session, there is \$270.00 that has been donated.
