BUSINESS FROM THE FLOOR

ROBERT WOHLGEMUTH/11849 GENESEE ST spoke about the Resolution presented to the Board re Moratorium on the Big Box Law. He feels the advice was that a moratorium could not be done since we don't have a Master Plan Review. He talked about the County Land, State Land, and the condition of Bry-lin. He stated that we like the rural Community – reviewing the restrictions in the Commercial and Development on residential in the Zoning Chapter – by starting this now and have the process working while the Master Plan is being updated. He feels that until this is started anyone can come in here and do what they want.

Jennifer Strong replied: (1)as for the County Land- they were contacted a few years ago and they said they were not interested in selling the Land; (2)Bry-lin has been sited by the Building Inspector. (Councilman Snyder said there will be new people moving in and it will be back on the Tax Roll and Councilman Weber stated that the Industrial Development Committee has shown that property) (3) as for the Moratorium issue – if someone comes in with a Big Box Application the Town call still adopt a Moratorium at that time (4) there are three (3) reasons for adopting a Moratorium- new technology (Windmills, Cell Towers) revamping your Zoning Code or revamping or adopting a

Comprehensive Plan – you also have to follow the provision of General Municipal Law 239M. The time limit has to be reasonably related to your project.

Paul Loehr/Henskee Rd stated he supports all of what Mr. Wohlgemuth presented. He wanted to know if the copy that Mr. Wohlgemuth has was the Comprehensive Plan. Supervisor Smith stated it was an update to the Comprehensive Plan – not the complete 1972 Comprehensive Plan – there are two (2) Volumes. Mr. Loehr asked if we need a Comprehensive Plan to do Zoning and the Attorney answered No.
