The old senior van has been sold. Upon receiving the check, the funds will be turned over to Erie County.

# **Supervisor Milligan:**

Supervisor Milligan read an e mail from Engineer Metzger.

Waterline – Construction began last Tuesday along Exchange Street. Over 650' were installed Tuesday through Thursday. Cold weather is hampering further work.

Highway Garage – Hwy. Supt. Wagner & Eng. Metzger met with the construction consultant last week. The consultant would like to talk to the town's engineer hired to look at the matter and a contractor that the town may use to make the repairs to get everyone on the same page. Engineer Metzger explained that it will have to be put out to bid publicly for a contractor. Engineer Metzger is awaiting a call from the structural engineer and will keep the Board informed of any development.

A letter was received from Hearts and Hands reporting that for Alden only they had 1,032 requests, 20,673 miles driven on behalf of Alden care recipients and over 1,130 hours of support services to Alden care recipients. Volunteers are needed.

The Alden Car Show was in last week. Their committee decided to change the name of the event to Alden, Car, Truck, and Cycle Show for 2015.

The Monthly report for the Tax Office was received from Town Clerk Crist \$964,000.00. Supervisor Milligan thanked Town Clerk Crist for being open on Saturday to give tax payers an extra day to come in and pay their taxes.

Alden Hook and Ladder's report for January 2015 was received.

WHEREAS, the Town of Alden and Alternative Care Services of WNY, Inc., a Not-For-Profit Corporation duly organized and existing under the laws of the State of New York, have been negotiating renewal of a Contract wherein Alternative Care Services of WNY, Inc. will provide Meals-On-Wheels to eligible residents of the Town of Alden;

WHEREAS, the Town of Alden is aware that a large number of residents of the Town of Alden are eligible for and participate in the Alternative Care Services of WNY Inc.'s Meals-On-Wheels Program and is desirous of obtaining such services for its residents;

WHEREAS, Alternative Care Services of WNY, Inc. is the sole source provider of a meals-on-wheels program in the Town of Alden and therefore the Town's Procurement Policy & Procedure Guidelines and General Municipal Law have been followed; and

WHEREAS, the Town of Alden and Alternative Care Services of WNY, Inc. have come to full agreement on the terms of such Agreement to run from January 1, 2015, until December 31, 2015.

#### NOW THEREFORE BE IT RESOLVED AS FOLLOWS THAT:

- 1.The Town Board approves the attached Agreement whereby the Town contracts with Alternative Care Services of WNY Inc., at a cost of \$1,000.00 for the provision of meals-on-wheels to eligible Town of Alden residents as being consistent with its policies and in the best interests of the residents of the Town of Alden;
- 2.That the Supervisor of the Town of Alden is authorized to sign any and all necessary documents to effectuate the Agreement; and
- 3. This resolution shall take effect immediately.

List of all towing companies;

Show itinerary and maximum amount of cars allowed;

# Car Show shall escrow \$1,000.00, pursuant to a signed Escrow Agreement, with the Town of Alden to cover any costs incurred by the Town;

And contingent upon the following conditions:

The Alden Hook & Ladder Fire Company Inc. may sell alcoholic beverages, within the limits of the laws of the State of New York, in a contained "Beer garden or beer tent" in the Alden Town Park from 12:00 pm until 6:00 pm on Sunday July 26, 2014, provided that a New York State Liquor license is first obtained. No spectator or show parking shall be allowed on the new sports fields in the Town Park; however Mercy Flight may land on these fields;

Car Show will contract with Empire towing for any needed towing services during the Car Show;

All security personnel must be Sheriffs, Troopers or trained security guards;

Fire Police or County Sherriff shall monitor the road closing and direct traffic for the duration of the car show, including the registration period at all closed roads;

Car Show personal shall throughout the day pick and empty trash cans;

Empty Trash cans to be returned to Town Park Garage at the end of the show;

Car show will reimburse the Town for having the Town dumpster emptied after the Car Show;

Car show to supply (and remove) port a potties;

Car Show to clean up to the satisfaction of the Town after the event;

First aid tent, coordinated with Alden Fire Department;

Any costs incurred by the Town of Alden (including labor costs) will be billed to the Car Show; Golf carts shall only be used only by the Fire Department to assist handicapped persons and to move supplies.
