WHEREAS, the Building Inspector has posted notice of the house being dangerous, unsafe, and a public nuisance on the property.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT:

- 1. That a Public Hearing be held before the Alden Town Board on July 15, 2019 at 7:05 PM at the Alden Town Hall, 3311 Wende Road, Alden, New York on the report made by the Building Inspector and to determine if the house is dangerous, unsafe and a public nuisance;

That the necessary Notice of Hearing, as required by Chapter 115 of the Alden Town Code be published in the Alden Advertiser, the official newspaper of the Town of Alden, and be posted on the Town Bulletin Board, and mailed to the property owner and other parties having an interest in the property, which Notice shall be in the form attached hereto and made a part hereof; and
