#### **BUSINESS FROM THE FLOOR**

John Bruso, Legislator – bringing updates from the County; he noted that Daniel Gniewecki has moved on from his Office. He accepted another position and is settling in well. They are still moving forward with Erie County Home. The County is getting more calls on turning property over to a broker. And ensuring the property is taking on an appropriate roll. Mr. Bruso does a quarterly tour of roads in his district. He touched base with Bill Rogers to go over what they are seeing as well. The rough roads are the same that everyone is seeing; Exchange Street being a major one. The County is working on plan to get them fixed. In conjunction with Alden Substance Abuse Coalition on adolescent vaping program, they had a packed house, a very good turnout. There is a large number of Middle School kids that vape. The current task at hand is not hindering business but making it more difficult for children to access the nicotine that comes from vaping.

Steve Fox, Wende Road – Inquired as to whether the Constable Law will open the door to paying for any other the cop cancers that were big in past years. He noted he thought Alden had dissolved its police force around 1980. Supervisor Savage noted that it was the Village who had the police force, not the Town. However, the Town had Constables in the 60s. Mr. Fox noted he was just concerned about left over payments that may have been due.

WHEREAS, pursuant to part 617 of the implementing regulations pertaining to Article 8 State Environmental Quality Review Act (SEQRA) it has been determined by the Alden Town Board, as Lead Agency, as solicited on February 11, 2019, that adoption of said proposed Local Law is an Unlisted Action and will not have a significant effect upon the environment;

WHEREAS, the Erie County Division of Planning issued a "no recommendation" to the 239-m Notice that was received by them on or about February 14, 2019;

WHEREAS, the neighboring municipalities were given notice of the proposed Local Law on February 22, 2019;

WHEREAS, said Local Law will not have any adverse impact on the current land uses in this area; and

WHEREAS, the Alden Town Board, after due deliberation, finds it in the best interest of said the Town of Alden to adopt said Local Law.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT:

- 1. The Alden Town Board hereby adopts said Local Law No. 1 of the Year 2019, entitled "Local Law to create the Position of Town Constable."" a copy of which is attached hereto and made a part of this resolution;
- 2. That the Alden Town Clerk enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Alden, and to give due notice of the adoption of said Local Law to the Secretary of State of New York, post the same on the Town Bulletin Board and publish the same in the Alden Advertiser; and
- 3. This Resolution shall take effect immediately.

LOCAL LAW TO BE ENACTED BY THE ALDEN TOWN BOARD TOWN OF ALDEN, NEW YORK

LOCAL LAW NO. 1 of the YEAR 2019

# A LOCAL LAW CREATING THE POSITION OF TOWN CONSTABLE

# BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF ALDEN AS FOLLOWS:

## § 1. Legislative intent.

It is the purpose and intent of this Local Law to create the office of Town Constable, which shall be a part-time position and as authorized by the NYS Criminal Procedure Law and the NYS Town Law. It is the purpose of this Local Law to promote the public health, safety, and welfare in the Town of Alden, by establishing the position of Town of Alden, Town Constable.

## § 2. Establishment of office.

The Town of Alden hereby establishes the part-time position of Town Constable, who shall be authorized to act in the full capacity established and set forth in NYS Criminal Procedure Law § 2.10 and shall have the responsibilities generally associated with such position in and about the Town of Alden as hereinafter set forth. Town Constables shall be appointed by the Town Board and shall work under the direct supervision of the Town Board. Town Constables shall perform such duties as the directed by the Supervisor, Town Board and or Town Justices for the Justice Court of the Town of Alden pursuant to the laws of the State of New York.

The Town Board may appoint as many Town Constables as it desires and shall provide for the amount and manner of payment for their services.

#### § 3. Status as peace officers.

Persons holding the position of Town Constable shall have the status of and shall be granted and exercise the powers of a "peace officer" under NYS Criminal Procedure Law (CPL). CPL § 2.10(1) sets forth those persons who are peace officers, specifically including a constable of a town; provided such designation is not inconsistent with local law.

#### § 4. Term.

A Town Constable shall serve at the pleasure of the Town Board and may be removed from the position by the Town Board for any or no reason whatsoever.

## § 5. Qualifications.

Minimum qualifications for the position of a Town Constable shall be an age of 21 years or more, to have a high school diploma, a valid New York State driver's license, and a pistol permit issued by the appropriate governmental agency, and to be a resident of the County of Erie or any adjoining county within the State of New York.

## § 6. Powers and duties of Town Constables.

Town Constables shall have, in addition to the powers granted herein, those special duties, powers and responsibilities consistent and generally associated with a peace officer in the State of New York, including the following court duties, but not necessarily limited to:

- A. Attending sessions of the Town Court to maintain order and decorum in the courtroom;
- B. Calming disruptive individuals;
- C. Barring entry into secure areas of and about the courtroom;
- D. Addressing and attending to disruptive prisoners, litigants and spectators involved in court proceedings;
- E. Escorting, guarding and delivering jurors, witnesses and other participants of court proceedings to and from the courtroom;
- F. Escorting, guarding and delivering the Judge and/or Court Clerk to and from the courtroom, as may be required;
- G. Delivering materials to sequestered juries;
- H. Escorting Court Clerks with bank deposits to and from the court offices and courthouse to the bank:
- I. Using established search procedures and equipment to assure that no weapons, contraband or other prohibited items or materials are brought into the courthouse or courtroom;
- J. Carrying, displaying and using a firearm, subject to any permit, training and certification requirements and qualifications otherwise imposed by law;
- K. Effecting arrests as required and authorized; and
- L. Providing protection and maintaining order and decorum at Town Board meetings or other meetings or events authorized by the Town Board.

# § 7. Firearms and other training.

As peace officers, Town Constables must be trained in accordance with CPL §2.30 and any other requirements set forth by the Alden Town Board; by the New York State Division of Criminal Justice Services (DCJS); and/or the Municipal Police Training Council (MPTC).

No person holding the position of Town Constable shall carry or otherwise possess a firearm on Town property other than in conformity with state and federal law, and after having successfully completed such initial training and instruction, and any required in service of follow-up training and instruction, required for a peace officer authorized to carry a firearm under the laws of the State of New York.

## § 8. Severability.

If any paragraph, section, sentence or portion of a sentence of this Local Law shall be found and determined to be invalid, unlawful and/or unconstitutional, such determination shall not invalidate or void any other paragraph, section, sentence or portion thereof, and such other portions thereof shall remain in full force and effect unless and until legally revoked, modified and/or amended.

#### § 9. Supersession.

It is the intent of this Local Law that the Town of Alden, pursuant to its Municipal Home Rule powers, hereby supersedes the requirements of NYS Town Law § 20(1), in allowing not more than four civil officers to be appointed in a Town of the first class in which a town police department has been established or which town is a part of a county police district; NYS Town Law § 23(1); NYS Public Officers Law § 3(1); and any other law of the State of New York requiring a Constable as appointed herein to be a resident of the Town of Alden.

#### § 10. When effective.

This Local Law shall take effect upon the filing thereof with the Secretary of State of the State of New York.

- 2. That the Supervisor of the Town of Alden is authorized to sign any and all necessary documents to effectuate this Contract; and
- 3. This resolution shall take effect immediately.
