Motion to move forward by Councilwoman Pautler

Roll by Deputy Town Clerk, Joanna Eisensmith.

Supervisor Adamski – welcomed parties to the meeting and provided rules of order.

Supervisor Adamski summarized failed negotiations and the background for the assertion that the Town Tax Base has largely been subsidizing the village Tax Base. He provided details siting NY State Law, and asked, "why are Town residents paying for, perhaps, as much as 88% of the total cost, of the Village Fire Budget?"

Mr. Supervisor continued, explaining since negotiations have failed, the Town has been forced to work with other departments to insure coverage for residents.

Public commentary opened with Alden Village, Deputy Mayor, Lauren Prucnal 1602 Westcott Ave. Who provided a brief history of Alden Fire Dept. He summarized His views on the financial negotiations, a history of accusations between the parties, and the background for renegotiations. He stated that the information requested by the Supervisor has been provided to the Town. He shared boundaries, coverage, and asked questions. Finally requested contracts *not* be signed.

Mr. Paul Loehr, 13369 Henskee Road – described what he called the "Number One Fire Company," Alden Fire Company" and provided a breakdown of households covered by each company. He stated the Alden H & L answers to 1088 addresses in Town, and sited specific concerns regarding potential increased response times. He specified the mileage between the different companies and his home, and asked reconsideration. Finally Mr. Loehr raised NY State Town Law, Chapter 62 in relation to boundary lines between Fire Zones, written agreements between parties, and public notice requirements.

Ms. Bernadette Roland 271 Sullivan Road – expressed concern about areas south of Broadway. She shared research about the number of homes in Alden. Ms. Roland described concerns (under the proposed contracts) of homeowners insurance increases of over \$400 per household, and suggested if (instead) taxes were increased, it would cost approximately \$47 per household.

Mr. Loehr added concerns that under the proposed changes, homeowner insurance would "rise by 30%, or more."

Supervisor Adamski responded, explaining that under the proposed contracts, substations would be required within 4.9 miles of any Alden home.

Mrs. Laura Loehr 13369 Henskee Road – stated NY State Law, requires a "permissive referendum" (by the voters) to change coverage boundaries. Mrs. Loehr asked specific questions, as to coverage and boundary lines? She also asked about the details of the amended contract, budgetary changes, and details of the alleged illegal activities? Mrs. Loehr also offered her views on response times, based on proposed distance, and proposed substations.

Melissa Goff, 150 Lavender Lane – described her family's personal experience with the fire company. Mrs. Goff quoted numerous response time statistics, added concerns for potential raises in insurance coverage, and asked the board to carefully consider this vote.

Mark Pruitt 1398 Kellogg Street – Mr. Pruitt addressed his fellow fire fighters, asked that they do not accept the contract, and asked the Councilwomen vote no.

Jim Guarino 13899 North Road – Provided a brief history of numerous fires in Alden answered by Alden Hook and Ladder. He shared personal experiences with Alden, and Crittenden Fire Companies, and thoughts on equipment owned by Alden H&L.

Thomas Weisbeck 11452 Broadway – Mr. Weisbeck offered a question to Town Attorney Jennifer Strong, regarding Mr. Loehr's concerns to Town Law. Attorney Strong advised Proposed Contracts are available for review, and specific questions regarding Town Law been reviewed by the Town's Special Council Attorney. Mr. Weisbeck then posed questions regarding substations, and the relationship to distance requirements, census, and NY State Law.

Mrs. Goff interjected, with concerns as to substations, distance, and response times. An anonymous commentator followed, refusing to provide her name, or residence.

Mrs. Laura Loehr – revisited NY State Law regarding a change of boundaries, permissive referendum, and requirements thereof.

Jennifer Boucher 13269 Irving Street – addressed her concern for a perceived lack of specific responses to questions regarding coverage, and mutual aid. She provided specifics on numbers of calls Alden H&L responded to from Town residents, and questioned how many, including visitors, drive-through motorists, student athletes, and others who might be negatively impacted by changes to coverage.

Jim Morris 260 Sullivan Road – asked why is there a problem with this specific Fire Company, and the contracts?

Supervisor Adamski responded; it started with Eric Mader reporting the village of Alden was paying two DPW worker's salaries out of the Fire Fund. The statement was followed by, numerous outbursts from the public.

Rich Hopcia 13379 Mercer Drive – commented regarding the proposed contract going into effect after the Supervisor's term has expired.

Don Stoffel 201 Old Three Rod Road – stated he received a text message from the Town Supervisor-Elect regarding a letter which to be read.

Scott Sitzman – questioned Councilwoman Pautler specifically regarding her term, and co-chair position on the Fire Committee, and asked specifically regarding future plans to address volunteerism for the fire departments, and future options for contract negotiations.

Councilwoman Pautler – responded to questions, clarifying her position, and stated she would like to move forward, in contracting with the Village of Alden, upon receipt of the proper documentation requested.

Bob Eleczko, Chief of Millgrove FD, and Disaster Coordinator – explained; all of this started a year ago, when Mayor asked for changing of the words of the contract. What was discovered in the process is, there are 7 years of audits missing. He added, His department pays \$7,000 annually for auditing. He does not understand why, audits have not been provided to the Town of Alden, as required by contract. Asking, why the other departments should have to pay thousands of dollars annually for audits?

Mrs. Goff confronted Mr. Eleczko directly. He responded. Numerous residents exchanged comments, amongst themselves, calling out.

Questioning returned, from Mr. Scott Sitzman, to Councilwoman Pautler.

Albert Boucher 13269 Irving Street – addressed Councilwoman Pautler directly, providing information regarding Alden H&L dispatched calls. Parties spoke over one another before the Supervisor requested the parties address only the contract related matters at this hearing.

Deputy Town Clerk, Joanna Eisensmith read aloud letters from Supervisor-Elect Brett Sitzman, and Mr. Peter DeLacy.

In brief, Mr. Sitzman's letter questioned allegations against the village, and Supervisor Adamski's (previously discussed) conversation between Himself and the Comptroller's office. Mr. Sitzman shared that He has also contacted the Comptroller's office, and received a different response. The Supervisor-Elect also raised His concerns about coverage, and substations, following his conversations with Chiefs and Trustees, from two of the Fire Companies.

Mr. DeLacy of 86 and 248 Exchange Street expressed His opinions on the importance of prioritizing safety, security and protection of residents/families, and requested Supervisor Adamski fund {Alden H&L} fire and protection company.

With all residents heard, Supervisor motioned for close the Public Hearing and go back to the Regular Town Board Meeting.

License Agreement to Permit Crittenden Volunteer Fire Department to Use the Town of Alden Highway Garage Facility for a Substation

LICENSE AGREEMENT

THIS AGREEMENT entered into this 7th day of December, 2021, by and between the TOWN OF ALDEN (the "Town"), a municipal corporation organized and existing under and by virtue of the laws of the State of New York and with offices and principal place of business at 3311 Wende Road, Alden, New York 14004, party of the first part, and the CRITTENDEN VOLUNTEER FIRE DEPARTMENT INC. (the "Fire Department"), a domestic not-for profit corporation organized and existing under and by virtue of the laws of the State of New York and with offices and principal place of business at 13415 Genesee Street, Alden, New York 14004, party of the second part. WITNESSETH, that the Town and the Fire Department, for the consideration hereinafter named, do hereby mutually agree as follows:

- 1. The Town hereby gives and grants to the Fire Department, and the Fire Department hereby accepts from the Town, a revocable license to use a 60' x 25' portion of the Town of Alden Highway Garage property located at 12800 West Main Street, Alden, New York for the purpose of creating and maintaining a substation for the Fire Department. The space to be occupied by the Fire Department pursuant to this Agreement is hereinafter referred to as the licensed premises. All of the foregoing shall be subject to the terms and conditions of this Agreement.
- 2. This Agreement shall be for a period commencing on January 1, 2022, and ending on December 31, 2026, provided, however, that the Fire Department may terminate the Agreement by delivery (by mail or by personal service) to the Town (at its address stated hereinabove) of a notice of the Fire Department's intention to terminate the said revocable license thirty (30) days after the delivery of said notice. At the expiration of said thirty (30) day period or on December 31, 2026, (whichever occurs earlier) (a) said revocable license shall terminate, and (b) the Fire Department shall, at its own cost and expense, immediately remove all of its equipment and vehicles from the licensed premises, and quit and surrender possession thereof to the Town in good order and condition, except for normal wear and tear.
- 3. The licensed premises shall be used, occupied, operated, maintained and repaired, so as to be in compliance with all applicable United States of America, New York State, County of Erie, and Town and Village of Alden statutes, ordinances, local laws, codes, rules and regulations.

- 4. The Fire Department shall take out and maintain during the term of this Agreement such public liability and property damage insurance as shall protect the Town from claims for damages for personal injury including accidental death, as well as from claims for property damage, which may arise from operations under this Agreement, and the amounts of such insurance shall be as follows: A single limit policy in the amount of at least \$1,000,000 for death or bodily injury and property damage liability claims, public liability insurance, blanket contractual liability, broad form property damage liability and fire legal liability. The Fire Department shall furnish a copy of the above-described insurance policy (or a certificate showing the issuance thereof) to the Town and shall also name the Town as the additional insured in said policy. Alternatively, the Fire Department may provide proof of such insurance coverage by furnishing to the Town a certificate of self-insurance.

 5. Fire Department agrees to reimburse the Town for any and all damages or injury to any real property or personal property of the Town that may arise, directly or indirectly, from the negligence, acts or omissions of the Fire Department, its officers, agents or volunteers.
- 6. The Fire Department agrees that the Fire Department will defend, indemnify, and save harmless the Town of and from any and all suits, claims, actions, or causes of action of every name and description brought against the Town for or on account of any death, injuries or damage received or sustained by any party or parties by or from the negligence of the Fire Department or any of the Fire Department's officers, agents or volunteers and arising from the Fire Department's use of this license Agreement. The Town agrees that the Town will defend, indemnify, and save harmless the Fire Department of and from any and all suits, claims, actions or causes of action of every name and description brought against the Fire Department for or on account of any death, injuries or damage received or sustained by any party or parties by or from the negligence of the Town or any of the Town's officers, agents or employees and arising during the Fire Department's use of this license Agreement.
- 7. Any and all notices and payments required hereunder shall be addressed to the parties at their respective addresses listed on page 1 hereof, or to such other address as may hereafter be designated in writing by either party hereto.
- 8. The revocable license granted herein
- (a) is not a conveyance of real property,
- (b) is not intended to grant or convey to the Fire Department the exclusive use of the land or building on which the substation is to be located,
- (c) is granted subject to grants, conveyances, easements, and rights-of-way heretofore made to others, and
- (d) is granted subject to the right (which the Town hereby reserves) of the Town

- (i) to use and enjoy the lands and building within the boundaries of the property described in Schedule A in any manner that does not unreasonably interfere with the right herein granted to the Fire Department, and
- (ii) to grant and convey easements and rights-of-way to others over, across, under, and through the lands and buildings within the boundaries described in Schedule A.
- 9. The Town reserves the right, exercisable at any time or from time to time, to relocate or cause the Fire Department to relocate the substation to another suitable location at the Highway Garage property. Any such relocation shall be at the Town's expense.
- 10. The Fire Department shall, at its own cost and expense, clean the licensed premises, if needed, after use by the Fire Department, and make any repairs for damages the Fire Department causes.
- 11. In exercising the right herein granted, the Fire Department shall
- (a) not prevent or block vehicular or pedestrian ingress or egress on or over the Highway Garage property,
- (b) not interfere with the activities or operation of the Town Highway Department,
- (c) arrange for and pay for all telephone service and equipment, computer services and equipment, and radio and communications equipment the Fire Department desires to obtain and use on the licensed premises, and
- (d) reimburse the Town (within 60 days after the Town submits to the Fire Department a written statement therefor) for 100% of any expenses incurred by the Town in bringing or furnishing electric, cable, or telephone services to the licensed premises, it being understood that the Town will pay the entire bill for any electricity used by the Fire Department at the licensed premises during the term of this Agreement.
- 12. The provisions of Paragraphs 5 and 6 of this Agreement shall survive any termination of the revocable license or of this Agreement.
- 13. The Fire Department shall not assign this Agreement, or its right, title or interest herein without the express, prior written consent of the Town.
- 14. This Agreement shall be construed in accordance with the laws of the State of New York, and constitutes the complete understanding and agreement of the parties with respect to the subject matter hereof. No modification of amendment of any of the provisions hereof shall be valid unless in writing and signed by both parties hereto.
- 15. The Town will maintain and pay for electric, gas and potable water at the Highway Garage.
- 16. The Fire Department in exchange for this license shall remit the sum of \$1.00 to the Town on each January 1 that this license is in effect.
