**BUSINESS FROM THE FLOOR**

**Supervisor Savage** welcomed the students from Alden Central School.

**Justin Huett** from 586 Cayuga Creek – recently purchased this property and is experiencing water issues. He has talked to CEO Snyder, who came out and viewed the problems and made suggestions. The seller did not disclose the water issues. At one point he had water flowing from one sump pump to the other

sewer pump through his basement. There is drainage that goes underneath the road, which is part of the County Highway covered by the Clarence satellite came out to look at the situation. The previous owner had installed their own make shift drainage of sorts which was not done very well and not up to code (probably) which is flooding the backyard. He has several issues. There was a very large pipe that the homeowner assumed was done by County Highway, it was not installed by the County and is causing a whole lot of water to pool in the backyard, which leads into Cayuga Creek. He would like to see that water find its way naturally to Cayuga Creek. Highway Superintendent Rogers will contact Dave from the County and then go and take a look at the area. CEO Snyder had gone out to the area and gave his assessment of the situation. All the water from across the street dumps into Mr. Huett's yard. There is no natural swale. The pipe could be extended back to the creek or a swale could be cut in. **Supervisor Savage** said if you have the elevation correct you can cut a swale to the back and get the water to the creek it should help him. Mr. Huett said he received good advice from CEO Snyder that helps. Highway Supt. Rogers said it is his understanding that the County has been out there year after year. **Supervisor Savage** said that anything that is Town related we will be willing to help out with or make contacts to those that can help. Highway Superintendent Rogers said the Highway can bring a trans over and help shoot some grades. **Supervisor Savage** asked Mr. Huett to take a video during the spring thaw.

### **Attorney Strong:**

WHEREAS, the Town Board of the Town of Alden is considering an application by Mark Metz for the subdivision of two (2) lots. The entire parcel currently consists of approximately 22.57 acres at 12750 North Road in the Town of Alden, further identified as SBL #108.00-1-28.1. The first proposed lot ("Parcel A") would be approximately 2.01 acre vacant parcel and the second proposed lot ("Parcel B") would be the remaining approximately 20.56+/- acre parcel containing the existing buildings (The "Proposed Action");

WHEREAS, the Proposed Action is an unlisted action within the requirements of the New York State Environmental Quality Review Act;

WHEREAS, the Town Building Inspector provided notice to the Erie County Division of Planning on December 20, 2017, for this Proposed Action, as required under Section 239-m of the General Municipal Law and no response was received.

WHEREAS, the New York State Environmental Quality Review Act requires the Town to determine the Lead Agency status and the Lead Agency making a SEQR determination;

WHEREAS, the Town of Alden did assume Lead Agency Status on January 16, 2018;

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law and the Code of the Town of Alden, Chapter 9D, the Town Board has prepared the Short Form Environmental Assessment Form, which is now on file with the Town Board and the Town's SEQR Intake Officer;

WHEREAS, the Town of Alden Planning Board has reviewed the Proposed Action and recommended to the Town Board the approval of the Proposed Action.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT:

1. The Town Board, as Lead Agency, has determined that the Proposed Action is an Unlisted Action under SEQRA.

2. The Town of Alden, as Lead Agency, hereby determines that the unlisted action described in the attached SEQR NEGATIVE DECLARATION, NOTICE OF DETERMINATION OF NON-SIGNIFICANCE, which attached notice is hereby made a part of this Resolution, will not have a significant effect on the environment and that an environmental impact statement is not required to be prepared with respect to the Proposed Action.

**Councilwoman Pautler:**

Councilwoman Pautler ordered the wall units for the Senior building today.

**Highway Supt. Rogers:**

**Eng. Metzger:**

The design for Sewer District #2 has been reviewed by the DEC and Environmental Facility Corp. and there has been no feedback as yet. Highway Supt. Rogers has brought to Eng. Metzger's attention grants that are available for bridgework/culverts. Engineer Metzger would like to get together with him on a couple of ideas that he has that would qualify. Hwy. Supt. Rogers said the grants include every aspect of the entire project. These can be costly projects. Hwy. Supt. Rogers is checking out the Town looking for possible culverts that might fit the criteria.

**Supervisor Savage:**

Supervisor Savage thanked CEO Snyder for his patience with himself and Dean in going through the Metz subdivision. At the Planning Board meeting there were many statements made that were not true. He is fully in compliance. It was done with one parcel without a house on it; there were not two houses on



that parcel. It is a big parcel with a shop on it on one end. That is what the survey put forth and we just approved a two acre parcel off that main parcel. Mr. Metz's house is on a different parcel. The dirt came from the University of Buffalo not Republic Steel, according to his Engineer that put that in writing. According to the Building Inspector, it is not wetlands where the house is. The septic system will be approved in the Spring. There was a plan submitted September 17, 2017, which will be revised as they went from three bedrooms to four. There is room on the lot for any system that will take care of the house. CEO Snyder checks with Jennifer Delaney with the County, who is the Engineer and who permits and approves the septic system. You cannot perk in the winter, as long as there is room to take any system on, it is okay to get the building permit. A lot of fluff about nothing. It was done by the book other than the basement was started before the permit was issued. Chris was on vacation and it was addressed immediately. It is a little distressing that accusations are made and reported as truth. The kitchen at the Community Center is finally done. Chris went over and looked at it. Andy was there. Supervisor Savage spoke to Paul D'Orlando. The paperwork should be all straightened out. There was a change order of \$1800.00.
