BUSINESS FROM THE FLOOR

Ron Rebmann of Broadway questioned the road repairs done by Erie County and why the roads are all being painted with double yellow lines. Supervisor Savage commented on the repairs saying that it is how Erie County handles them. As far as the double yellow lines Supervisor Savage could sympathize with Mr. Rebmann stating how frustrating it can be to get stuck behind a big truck or a vehicle doing less than the speed limit.

Supervisor Savage:

- Supervisor Savage received a phone call from Assemblyman Norris's Chief of Staff indicating that we could receive a \$30,000 reimbursement (earmarked for Alden) for a Four Seasons park shelter from the Assemblyman's office via a DASNY Grant. Throughout the past 3 years \$170,000 has been set aside for the project. SEQRA has to be done first.
- Request from the Alden Home Bureau to use the large room at the Community Center on the 1st, 3rd & 5th Mondays of the month from 7:00-9:30 Sept. 2018-Sept. 2019. They are also requesting a key as they meet at nighttime.
- 3. Received Certificate of Liability Insurance for 2018 Alden Men's & Woman's Softball Tourney
- 4. Notice of Disapproval from CEO Chris Snyder for an addition on a residential premises at 12232 Blossom Lea Dr.
- 5. Notice of disapproval from CEO Chris Snyder for the building of an accessory building on a residential premises at 12407 Reinhardt Rd.
- 6. Letter from Elizabeth Ricci, Program manager for EFC sent a letter regarding the Clean Water State Revolving Fund (CWSRF) project No. C9-6636-02-00 Sewer District No. 2 Wastewater Treatment Plant Improvements stating the submission is eligible for the CWSRF financial assistance by the EFC and giving actions for timely disbursements.

WHEREAS, Roy Fassel has filed an application for a Special Use Permit to Harbor Chickens at his residence located at 642 Creekside Drive in the Town of Alden (further identified by SBL # 118.14-5-4); and

WHEREAS, the Town Code Enforcement Officer has inspected the premises and has

found the same in compliance with all requirements of the Alden Town Code;

WHEREAS, the notice of public hearing was mailed to neighboring parcel owners and the public hearing was held on June 18, 2018, after due publication in the Alden Advertiser; and

WHEREAS, at said public hearing all persons appearing in favor of and against the proposed action were heard and all concerns have been addressed.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS, THAT:

1. The Town Board hereby directs the Code Enforcement Officer to issue to Roy

Fassel a Special Use Permit to Harbor Chickens limited to six hen chickens for a period of one year; and

WHEREAS, the Alden Town Board is considering an application by Michael Hoinski for the subdivision of two (2) lots. The entire parcel currently consists of approximately 53.714 acres at 420 Exchange Street, in the Town of Alden, further identified as SBL 130.00-3-1.11. The first proposed lot ("Parcel A") would be approximately 2.135 acre vacant parcel and the second proposed lot ("Parcel B") would be the remaining approximately 51.579 +/- acre parcel containing the existing buildings (The "Proposed Action");

WHEREAS, the Town Board has determined that the Proposed Action is an Unlisted Action under SEQRA;

WHEREAS, the Town Board believes that the Town of Alden is: the agency primarily responsible for undertaking decisions as to subdivision; the agency with the broadest governmental powers for investigating the impact of the Proposed Action; has the greatest capacity for providing the most thorough environmental assessment of the Proposed Action; and is the most local agent with permitting authority;

WHEREAS, the Town Building Inspector has provided notice to the Erie County Division of Planning for this Proposed Action, as required under Section 239-m of the General Municipal Law.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT:

1. The Town Board has determined that the Proposed Action is an Unlisted Action under

SEQRA.

2. The Town Board has determined that it should be the Lead Agency for all environmental review of the Proposed Action.

3. This resolution shall take effect immediately.
