Resolution to Adopt Erie County Hazard Mitigation Plan

THE FOLLOWING RESOLUTION WAS OFFERED BY _____, WHO MOVED ITS ADOPTION, SECONDED BY _____

WHEREAS, all jurisdictions within Erie County have exposure to hazards that increase the risk to life, property, environment, and the County and local economy;

WHEREAS; pro-active mitigation of known hazards before a disaster event can reduce or eliminate long term risk to life and property;

WHEREAS, The Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for pre- and post-disaster hazard mitigation programs;

WHEREAS; a coalition of Erie County municipalities with like planning objectives has been fanned to pool resources and create consistent mitigation strategies within Erie County; and

WHEREAS, the coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating and revising this strategy.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT

1. The Town of Alden adopts in its entirety, the 2022 Erie County Hazard Mitigation Plan (the "Plan") as the jurisdiction's Hazard Mitigation Plan and resolves to execute the actions identified in the Plan that pertain to this jurisdiction;

2. Will use the adopted and approved portions of the Plan to guide pre- and post-disaster mitigation of the hazards identified;

3. Will coordinate the strategies identified in the Plan with other planning programs and mechanisms under its jurisdictional authority;

4. Will continue its support of the Planning Partnership as described within the Plan;

5. Will help to promote and support the mitigation successes of all participants in this Plan;

6. Will incorporate mitigation planning as an integral component of government and partner operations;

7. Will provide an update of the Plan in conjunction with the County no less than every five years; and

8. This resolution shall take effect immediately.
