WHEREAS, the Town of Alden, New York Town Board desires to provide initial funding into a publicity fund utilizing the \$25,000 appropriated in the Town of Alden, New York's 2021 Adopted Budget.

- 1. The Alden Town Board establish a publicity fund to make expenditures relating to its bicentennial utilizing the \$25,000 appropriated in the Town of Alden's 2021 Adopted Budget; and
