Eric Ahl, 1265 E. Laray – Any new business for Ledgestone Village? Supervisor Sitzman – there are no Ledgestone items on the agenda.

Jim Testa, 3310 Crittenden – Purchased home next to the church at 3320 Crittenden. A retaining wall was put up poorly, it has since partially fallen over. Case was previously is court. Home owner showed Town Board members pictures of the wall.

CEO Snyder – case was dismissed from Court. Property is now bank owned. Supervisor Sitzman – To CEO Snyder, based on the photographs provided is there a violation? CEO Snyder – yes, the violation would go to the current owner; M&T Bank. Will look into issuing a new violation.

Attorney Strong – new violation could be sent to Court.

Holly Ahl, 1265 E. Laray – concerns with Ledgestone Village. A swale or ditch does not mean water is not seeping into the ground. Two out of three homes on E. Laray, that has a ledgestone Village unit behind their house, have first time water problems in their basements. They have only built behind three houses on E. Laray. Brad, who will be speaking next, is one of the ones with first time water problems.

Bradley Bowen, 1241 E. Laray – most recent build in Ledgestone is behind his house. Since purchase of the home in 2022 has had no water problems. Since the latest phase of Ledgestone sump pump runs constantly, water is pooled around foundation, has made its way through foundation walls and runs across basement floor. Provided photos to show change of elevation behind his house. Has questions regarding foundation and elevation. Noted millings and fill were bought in to build up the elevation before foundation was poured. Questioned approved elevation vs. what elevation actually is. Questioned inspection process for pouring footer. Does Chris or Mike know where fill is being brought in from? Has fill been tested? Rain water could be pushing potential contaminants from fill to home with well water. Who is responsible for erosion control? Should silt sock line entire property? Based on elevation the proposed 8ft fence would not do very much, what are other options considering the properties are built so high? Why would an engineer put the buildings up so high? What elevation plans will be carried through? Neighboring properties are lower and susceptible to more problems.

Art Eisensmith, 1257 E. Laray – has water issues in basement now. Getting an estimate for drain tile. Has anyone spoken to Lucas James about neighborhood petition?
