LICENSE AGREEMENT

THIS AGREEMENT entered into this ____ day of April, 2025, by and between the Alden Evergreen Cemetery, Inc. a Non-For-Profit Cemetery Corporation organized and existing under the laws of the State of New York with a principal place of business at 7 Woodbrook Drive # 2, East Aurora, New York 14052, party of the first part, ("Cemetery") and TOWN OF ALDEN (the "Town"), a municipal corporation organized and existing under and by virtue of the laws of the State of New York and with offices and principal place of business at 3311 Wende Road, Alden, New York 14004 party of the second part.

WITNESSETH, that the Cemetery and Town, for the consideration hereinafter named, do hereby mutually agree as follows:

- 1. The Cemetery hereby gives and grants to the Town, and the Town hereby accepts from the Cemetery, a revocable non-exclusive license to use the storage shed located at the rear of the Alden Evergreen Cemetery located at 13041 Broadway, Alden, New York for the purpose of storing the Town's lawn maintenance equipment that the Town uses to maintain the Alden Evergreen Cemetery. The space to be occupied by the Town pursuant to this Agreement is hereinafter referred to as the licensed premises. All of the foregoing shall be subject to the terms and conditions of this Agreement.
- 2. This Agreement shall be for a period commencing on April ___, 2025, and continuing until either party gives thirty days written notice, by first class mail, to the other part of the termination of this License Agreement. At the termination of this Agreement: (a) said revocable license shall terminate, and (b) the Town shall, at its own cost and expense, immediately remove its lawn maintenance equipment from the licensed premises, and quit and surrender possession thereof to the Cemetery in good order and condition.
- 3. The Town agrees to reimburse Cemetery for any and all damages or injury to the shed that may arise, directly or indirectly, from the negligence, acts or omissions of Town or any of the Town's employees, officers, agents or volunteers.
- 4. The Town agrees to shore-up the shed: including repairs, but not replacement of the siding and door.
- 5. Town agrees that the Town will defend, indemnify, and save harmless Cemetery of and from any and all suits, claims, actions, or causes of action of every name and description brought against the Cemetery for or on account of any death, injuries or damage received or sustained by any party or parties by or from the negligence of the Town, or any of the Towns's officers, agents or volunteers and arising from the Towns's use of this license Agreement. The Cemetery agrees that the

Cemetery will defend, indemnify, and save harmless the Town of and from any and all suits, claims, actions or causes of action of every name and description brought against the Town for or on account of any death, injuries or damage received or sustained by any party or parties by or from the negligence of the Cemetery or any of the Cemetery's officers, agents or employees and arising during the Town's use of this License Agreement.

- 6. Any and all notices required hereunder shall be addressed to the parties at their respective addresses listed on page 1 hereof, or to such other address as may hereafter be designated in writing by either party hereto.
- 7. The revocable license granted herein: (a) is not a conveyance of real property, (b) is not intended to grant or convey to the Town the exclusive use of the land or shed on which the lawn maintenance equipment is to be stored, (c) is granted subject to grants, conveyances, easements, and rights-of-way heretofore made to others, and (d) is granted subject to the right (which the Cemetery hereby reserves) of the Cemetery to use and enjoy the lands and shed within the Alden Evergreen Cemetery, in any manner that does not unreasonably interfere with the right herein granted to the Town, and
 - 8. The Town shall not assign this Agreement, or its right, title or interest herein.
- 9. This Agreement shall be construed in accordance with the laws of the State of New York, and constitutes the complete understanding and agreement of the parties with respect to the subject matter hereof. No modification of amendment of any of the provisions hereof shall be valid unless in writing and signed by both parties hereto.

Chapter 95

ALCOHOLIC BEVERAGES

| ARTICLE I | § 95-3 . | Open containers prohibited. |

ARTICLE I

Possession in Town Parks and Community/Senior Center [Adopted 6-1-1981 by L.L. No. 3-1981 (Ch. 3, Art. I, of the 1981 Code)]

§ 95-1. Legislative intent.

It is the intent of the Town Board of the Town of Alden, as an exercise of its police power, to promote the general health, safety and welfare of the residents of the Town by enacting this article, since it is the finding of the Town Board that the possession of open containers of alcoholic beverages and/or the consumption of alcoholic beverages by persons in the Town parks and Community/Senior Center of the Town of Alden, except under controlled conditions, is detrimental to the health, safety and welfare of the residents of the Town and contributes to the development of unsanitary conditions and the creation of nuisances.

§ 95-2. Title.

This article shall be known and may be cited as the "Town Alcoholic Beverages Law."

§ 95-3. Open containers prohibited.

- A. No person shall have, possess, carry or transport any liquor, wine, beer or other alcoholic beverage in an open bottle or other open container in the Town parks and Community/Senior Center of the Town of Alden.
- B. No person shall drink or otherwise consume any liquor, wine, beer or other alcoholic beverage in the Town parks, Community/Senior Center Town of Alden.

§ 95-4. Permit required.

- A. If any individual or organization desires to have, distribute or consume alcoholic beverages in the Town parks, Community/Senior Center Town of Alden, said individual or organization must apply to the Town Board, Town of Alden, or its duly authorized representatives for a permit therefor at least seven days prior to the date scheduled for using such beverage. No fee shall be charged for the granting of said permit.
- B. A permit shall be issued only upon the following conditions:
 - (1) Such individual or organization by its duly authorized agent must agree, in writing, to assume full responsibility for supervising the conduct of the group or individuals benefiting from such permit and to properly clean up and restore the premises after use to their prior condition. The permit shall be available for display upon the request of any police enforcement officer.
 - (2) Such individual or organization must further agree, in writing, that adequate precautions shall be taken to ensure that minors will not be served or allowed to consume alcoholic beverages at the permitted event or gathering.
 - (3) No alcoholic beverages shall be distributed or consumed other than on the specific premises described in the permit and only during the time stated therein.
 - (4) No permit shall be issued to any individual or organization which has previously been issued a permit and has failed to comply with the provisions thereof, except when authorized by the Town Board.
 - (5) Such individual or organization possesses the proper license from the NYS Liquor Authority.

§ 95-5. Discarding of containers.

No person shall discard alcoholic or other beverage containers within the Town Parks or Community/Senior Center, except in appropriate Town trash receptacles.

§ 95-6. Penalties for offenses.

The violation of any of the provisions of this article shall be punishable by a maximum fine of \$250 or by imprisonment for 15 days, or by both such fine and imprisonment. Each day any violation shall continue shall constitute a separate violation.

Parks and recreation areas — See Ch. 249.

§ 122-1. Applicability of park rules and regulations.

All park rules and regulations (where applicable), as set forth in Chapter 249, Parks and Recreation Areas, of the Town Code, shall apply to the use of the Community/Senior Center and Town Hall Gym.

§ 122-2. Teenage groups.

Teenage groups must be chaperoned by at least one adult or more as may be required by the Town Board, for every 20 youngsters.

\S 122-3. Rental for Private parties and fundraisers .

The use of the Community/Senior Center or Gym by individuals and entities for private

affairs or functions, such as birthday parties, showers, confirmation parties, wedding parties, wedding receptions, card parties, anniversaries, graduations and bar mitzvahs, and for fundraisers is allowed, pursuant to rules established by resolution of the Town Board. Use by individuals or entities for non-community and/or profit ventures is excluded.

§ 122-4. Uses of more than one occurrence

Any use of more than one occurrence shall not be granted by the Town Clerk without the prior approval of the Town Board.

§ 122-5. Cancellation of application by Town Board.

The Town Board has the right to cancel any approved application for the use of the Community/Senior Center or Gym when the use of such facility is deemed necessary by the Town Board for its agents or employees.

§ 122-6 ALDEN TOWN CODE § 122-9

§ 122-6. Use by nonprofit organizations.

Only nonprofit and/or community organizations of the Town of Alden shall be permitted to use the Community/Senior Center or Gym for the organization's meetings or programs at no cost.

§ 122-7. Maintenance of facility by applicant.

In addition, the applicant for the use of the Community/Senior Center or Gym shall comply with the general rules as established by resolution of the Town Board provided for the use and cleaning up of that portion of the premises used and shall be responsible for any damage or breakage resulting from said use

§ 122-8. Application.

All persons and/or organizations seeking a permit to use the Community /Senior Center shall file an application with the Town Clerk along with any required fee.

GENERAL REFERENCES

 ${\bf Alcoholic\ beverages\ in\ Town\ parks--See\ Ch.\ 95,\ Art.\ I.}$

§ 249-1. Use of parks.

The Town parks are to be used by Town and Village of Alden residents and their guests only.

§ 249-2. Rules and regulations.

It shall be unlawful for any person to do any of the acts hereinafter specified.

- I. Hours. For any reason to enter a park prior to 6:00 a.m. or to remain within the park after sundown.
 - (1) Special extension. If an organization or resident wishes to have the hours extended, this may be done upon request of the organization or resident to the Town Board, the Supervisor or a duly appointed representative at least five days prior to the reservation date. Approval of this request shall be granted by the Town Board, the Supervisor or a duly appointed representative.
 - (2) Hours of operation of recreation. The Recreation Director shall have the authority to extend the hours of access to the confines of the park when, in the judgment of the Director, public interest demands it.
 - (3) In case of an emergency or when, in the judgment of the Town Board, the Supervisor, the Recreation Director or a duly appointed Town representative, the public interest demands it, any portion of a park may be closed to the public or to designated persons until permission is given to reopen.
- J. Firearms. For any person to take or otherwise transport any firearms, air guns, slingshots or bows and arrows in a park. Responsibly supervised archery events will be allowed with written permission of the Town Board.
- K. Preservation of property. For any person to injure, deface, disturb or befoul any part of a park or any of the buildings, signs, equipment or other property found therein or to remove, injure

or destroy any tree, flower, shrub, rock or other mineral. The peeling of bark or the cutting or injuring of trees is prohibited.

L. Fires. For any person to light any fire for any purpose in the park except in a stove, oven or fire circle provided for that purpose. Lighted matches must not be

deposited or left where they may cause fires.

- M. Garbage and refuse. Grounds must be maintained in a clean and sanitary condition. Littering of any kind is strictly prohibited. Garbage and refuse must be deposited in the receptacles provided.
- N. Dogs. For any person to bring dogs into a park unless the same are on a leash and kept on a leash while in the park.
- O. Hunting, fishing and trapping. For any person to hunt or trap game within park boundaries or for any person to fish within park boundaries where posted.
- P. Bathing and swimming. For any person to bathe or swim in any of the streams, pools or lakes in the park, except where and as prescribed by special rules governing the same.
- Q. Horses and riders. Horses and their riders are prohibited from using park areas, excepting over bridle paths or other paths established for said purposes. No rider shall travel at a gait in excess of a trot while in the park to preserve the safety of the public and avoid endangering children at play.
- R. Speed limit. No person shall drive or cause to be driven along or over any road within the park any vehicle at a speed or in a manner which endangers the life or limb of any person, and in no event shall the speed of any vehicle exceed 10 miles per hour, nor shall any person park or cause to be parked any vehicle at any point where a sign prohibiting parking has been erected pursuant to a direction of a Town employee or by the Town Board. Motorcycles, motor bicycles and motor scooters are to be parked at the parking lots and not driven off the paved highways.
- S. There is no vaping, smoking of cigarettes, cannabis or other materials anywhere in or on the Town Park or Recreation Area
- T. Glass containers. For any person, firm or corporation to possess any glass beverage container within the park
- U. Loud noise. For any person to cause loud noise such as which disturbs other persons within the park or on property adjacent thereto.
- V. N. Alcoholic beverages. For any person, firm or corporation to possess any alcoholic beverage within the park unless permitted to do so by permit issued by the Town of Alden.
- O. Commercial enterprises. For any person, firm or corporation to sell or offer for sale for the purpose of earning a profit when the sale is part of a community event within the park any property or privilege whatsoever, unless authorized by the Town Board.
- P. Park reservations. Alden residents and organizations may reserve shelters at the Town park.
 - (1) The Town Clerk shall have the authority to grant permission to individuals who are residents of Alden to use the Town park shelters. Reservations will not be accepted before April 1 of the year of use.
 - (2) At the discretion of the Town Clerk, organizations of the Town of Alden, through their representatives, may be granted use of the Town park shelters after January 1 of the year of use. An exception to this rule would be organizations or individuals selling tickets for an event or products at the event. In such cases, permission is to be granted by the Alden Town Board at a regular meeting or special meeting of such Board.

§ 249-3. Penalties for offenses.

Violation of any of the foregoing rules and regulations set forth in § 249-2A through M, inclusive, shall constitute an offense, and a person guilty of such offense shall be punishable by a fine not exceeding \$250 or by imprisonment not exceeding 15 days, or both such fine and imprisonment.
