BUSINESS FROM THE FLOOR

Matthew Rennicks (11820 Genesee):

- Would like to have two more events in 2026 similar to recent "Small Business" Fair help recently in the fall.
- Would like to start getting our paperwork as soon as possible. We did the last event in a month and a half.
- We raised \$800 for donation. One half to Andrew's Army (blood bank) and one half to Rozwell Cancer.
- We are looking for a spring date and a fall date. Possibly May 16th and October 03rd.
- Gina helped us out a lot. We want to make it bigger.
- Meals on Wheels is involved. And the Substance Abuse Coalition as well. Connie Babcock is backing me up (co-organizer?)
- I doubled my insurance. We would like to double our profits for charity.
- I am a cancer survivor and we want to give back

- WHY do we not have a carnival anymore?
- I have questions about Rules and Regulations that are not in the current paperwork. Concrete usage and how far we can go down with safety liability.
- We pulled from Como Park event (held on same day)

Supervisor Pautler and Board comments to Mr. Rennicks:

- o Carnival was put on by the Fire Department. That would be a question for them.
- O Please submit everything that you submitted for the recent event and we can discuss it at a Work Session. It's never too early as that is our Fall Baseball season and Spring sports.
- When you bring your proposal to the Work Session you can attend the Work Session. If we have questions you will be there to answer them.
- Once you get the application in then we'll get it on the Work Session.
- O Councilmember Kerl: Matthew, that's important that people like yourself bring this stuff into the community. This is what makes Alden special.

Christopher Tornabene (11631 Parkwood Dr.):

- I've been trying to talk to the Building Inspector and I understand there is a lot of movement in that office right now. I hope this is the place to talk about this.
- I live at the last house on the west end of Parkwood Dr.
- I want to voice my concerns and get some information about that new build.
- I will follow up with the Building Inspector when I can.
- I work in Orchard Park and we moved to Alden for a little bit of land and some privacy.
- We had a 15 foot (tall) hedge row was cleared by Marzec Development including about 100 feet of mature raspberry bushes and including trees. These trees offered shade to our gardens that we planted as shade gardens. My fiancée put \$1000s of plants for shade and invested hundreds of hours.
- We received an unaddressed and unstamped letter in our mailbox telling us to check our survey maps. We did have a professional surveyor come out. The (title) clearing company did indeed make a mistake and intrude on Marzec's land by about 5 or 6 feet.
- That letter also stated that building a house at that location fit the aesthetic of the neighborhood. This street is all ranches and he builds large \$750,000 houses.
- We put in a 6 foot privacy fence. Where he plans on building this house it's going to look right over our fence.
- It's pretty upsetting to us as we built there specifically for the trees.
- We are working with the clearing company in terms of the bushes removed but it's going to be a bit of a process for us.
- Snow removal: they always push the snow to the dead end of the roadway. Now where are they going to put it? On my property since my driveway is not too far from the dead end. There's a fire hydrant at the other end and I would hope they wouldn't put the snow there.
- Mail pick up: can they put a mailbox there? The entrance to the driveway is the tip of the dead end. There's nowhere else to put the driveway that doesn't intrude on either person's property.
- Garbage pickup: I don't want their trash cans on my property. And the garbage truck can't turn around.
- The reason I am here on November 01, 2021 there was a Zoning Board of Appeals meeting. Marzec Development requested a variance because they needed a 100 feet of frontage. That variance was unanimously denied.
- Miraculously at the next Planning Board meeting that variance was approved because there was 100 feet of frontage. There is not 100 feet of frontage.
- My concern is I don't know how he got approval to build there and there is a For Sale sign there.
- I want to voice my concerns and get some answers.
- Marzec did in the past commit to maintaining a tree line between the properties to the prior owner of my property. All the trees are completely gone and I can see Two Rod Road now.
- The two meetings were: Zoning Board of Appeals was 11/01/2021 and the Planning Board Meeting was 11/08/2021.

Jennifer Strong (Town Attorney): I can review the minutes of those two meetings and report back to the Board.

Jillian Nachtrieb (35 Two Rod Road):

- As Chris just told us, my family moved on to Two Rod looking for privacy and looking for the country feel. We used to live in Clarence.
- When we first bought the property it was from Marzec. The listing said it was just under TWO acres. We thought it was beautiful with a tree line behind us.
- Once we got into the process of buying the house we learned that survey sketch we learned that our property was actually just under ONE acre of land. (0.8 acres)
- Mr. Marzec chalked it up to the minutes of the Town and said that the survey hadn't caught up with the listing.
- In lieu of that mistake Marzec offered an easement so that we had the right to walk across his property to get over to Parkwood.
- The easement still stands and our lawyer sent a letter to Mr. Marzec letting him know that there should be a notation on the listing that there is an easement (on Mr. Marzec's land that is for sale).
- To our knowledge there isn't a permit for a house to be built on this land. We thought it was New York State law that you need a permit to build a house.
- Why is Mr. Marzec allowed to have this For Sale sign up and a listing for this on Zillow?
- We want to bring to light these things.
- We feel that this was a deception. And the (current) listing of Marzec's land and our original survey depiction show two different boundaries. We understand that this is just a rendering. People need to understand what they're buying.

Supervisor Pautler and Board comments to Mr. Rennicks:

- **Jesse Jesonowski** (CEO, Building Inspector) answering Supervisor Pautler: Mr. Marzec is scheduled to come in and discuss a number of permits. I can also talk with you (Jillian) about this.
- **Mike Metzger** (Town Engineer) Jesse, are you familiar with the application for the subdivision and the variance and plans?
- **Jesse:** Not with Cary Rd. but I have been working on Marzec's permits.
 - o Jesse and Jillian have discussion about the area.
 - Councilmembers thank the resident Jillian for bringing the matter to the Board's attention and want to schedule a meeting with Jesse.

Justin Napieralski (27 Two Rod Road):

- I want to echo what Christopher on Parkwood and Jillian on Two Rod have just said.
- Emily and I bought our house in one of Paul Marzec's first new developments.
- Similar problem with the TWO acre listing but less than ONE acre in actual size. (0.8 acres)
- It is starting to sound like a repetitive thing (with Marzec) that you come in thinking you are getting one thing and go through the process and you find out that it's something different.
- I found out when talking with the tax department that the acreage wasn't quite right. The acreage assigned to our lot was different. The combination of information that I was hearing from Paul Marzec and the Tax department was that someone was doing something right. That was in February and hopefully our taxes are getting straightened out.
- We moved to Alden looking for the privacy without living in a subdivision like Marrano homes, etc. It was kind of private and lots of trees that were removed.
- Another comment from Marzec to feel free to walk on his lot back to Parkwood. Emily and I would need permission from new owner as we don't have an easement from Marzec.
- We would have liked a heads up that this was happening. (new build) I took down a large pine tree and would not have done that if I had known.
- Powerlines moving and trees no answer as to that process back in August.
- The whole thing changed from what we thought we were getting and our expectations. So much changed 8 months into being in our first home.

Jennifer Strong (Town Attorney): Jesse, I will pull up the previous subdivision approval and make sure those legal descriptions are over to you. That will help you look at the plans that go back maybe ten years. I will find those historical records and get them over to your office.

Jesse Jesonowski (CEO): We need to make sure that what was approved and what he is doing are the same.

Supervisor Pautler: We need to make sure that there is a legal easement on the property. **Councilmember Waiss**: Discussion with residents regarding the attorneys at closing and did they catch the difference in lot sizes.

Kevin Martin (3551 Townline Rd.):

- I want to bring Urgency to the need for the (Townline) Water District to happen.
- I'm not sure if the Board is aware but there's numerous homes in our area in Corfu and south and north that are losing their wells. Exponential.
- I don't know how long my well is going to last. I can get water from my old house. But in the winter this won't be possible.
- You're on the Board. You could call State, County, Federal people to get a date.

Jennifer Strong, Town Attorney: It's in the State Comptroller's hands now. I received a strange phone call on Friday from the Clerk of the Erie County Legislature telling me that the State Comptroller's office had sent them a letter regarding the Townline Water District. My best guess is that there was supposed to be a copy of the letter sent to me as I was CC'd on the bottom. I haven't received a copy. They are supposed to file it with the Erie County Clerk, not the County Legislature. I have reached out to the Comptroller and asked what was going on and I haven't received a response yet.

Councilmembers comments: Can residents contact the State to put pressure on them? Can anyone? Is there anyone within the Comptroller's office that we should be directing the calls to? YES. Call local representatives at County and State. Tell them it's about the Approval of the Townline Water District. State reps DiPietro and Gallivan would be the ones to go straight to put pressure on the State Comptroller's office. You've been very patient Kevin.

• **Kevin Martin**: I would ask all of you to go home and turn off your water and put a bunch of spoiled eggs all over your house. I am getting 'iron mud' out of the ground. It's just horrible. I think it's the drought. It may take years to fill my well because it's over 100 feet deep. It's 847 days since we started this journey (for Townline Water District) – started in June of 2023. I did all the work to get it going.

Local Law No. 6 of 2025 (text as of 9.9.25)

Town of Alden, County of Erie

Title: Override of Tax Cap

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF ALDEN, COUNTY OF ERIE AS FOLLOWS:

SECTION ONE Legislative Intent

The State Constitution, Article XVI, §1, reserves all taxing power to the State and therefore local governments possess only that taxing power which has been expressly delegated to them by the State Legislature (Opns St Comp, 1990 No. 90-39; Opns St Comp, 1981, No. 81-331; Opns St Comp, 1973, No. 72-1085, unreported; 23 Opns St Comp, 1967, p 788).

The Town Board of the Town of Alden, County of Erie has reviewed the financial needs and obligations of the town. Due to contract obligations, limited revenue from non-real property tax sources, the rising cost of commodities and health care, compliance with unfunded mandates, reductions in state and federal revenue sharing programs coupled with the limitations on raising revenue set forth in General Municipal Law, §3-c, the Town Board of the Town of Alden, County of Erie, hereby determines that it necessary to override the tax cap for the fiscal year 2026.

SECTION TWO Authority

General Municipal Law, §3-c (5) authorizes the town board to adopt a local law overriding the tax cap by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

SECTION THREE Tax Cap Override

The Town Board of the Town of Alden, County of Erie hereby overrides the tax cap as required by General Municipal Law, §3-c as for the town fiscal year of 2026.

SECTION FOUR. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION FIVE. Effective date.

This local law take effect immediately upon filing with the Secretary of State.
