# **Recusal vs Abstention**

Chairman Drinkard issued an explanatory letter on April 16 regarding annual disclosures, transactional disclosures, recusals and abstentions. The letter was basically a rewrite of the guidelines issued in October, 2017 and April, 2018 with additional clarification.

#### **Annual Disclosure Inconsistencies**

The fourth and final inconsistency has been resolved; the individual actually did not recuse during calendar year 2018 and the submission was in error.

### **Annual Disclosure Forms Revision**

Revision of the annual form, aimed at clarification around reporting "Transitional Disclosures", is still pending; the Disclosure Review Committee will make a proposal to the full Board at a future meeting.
