

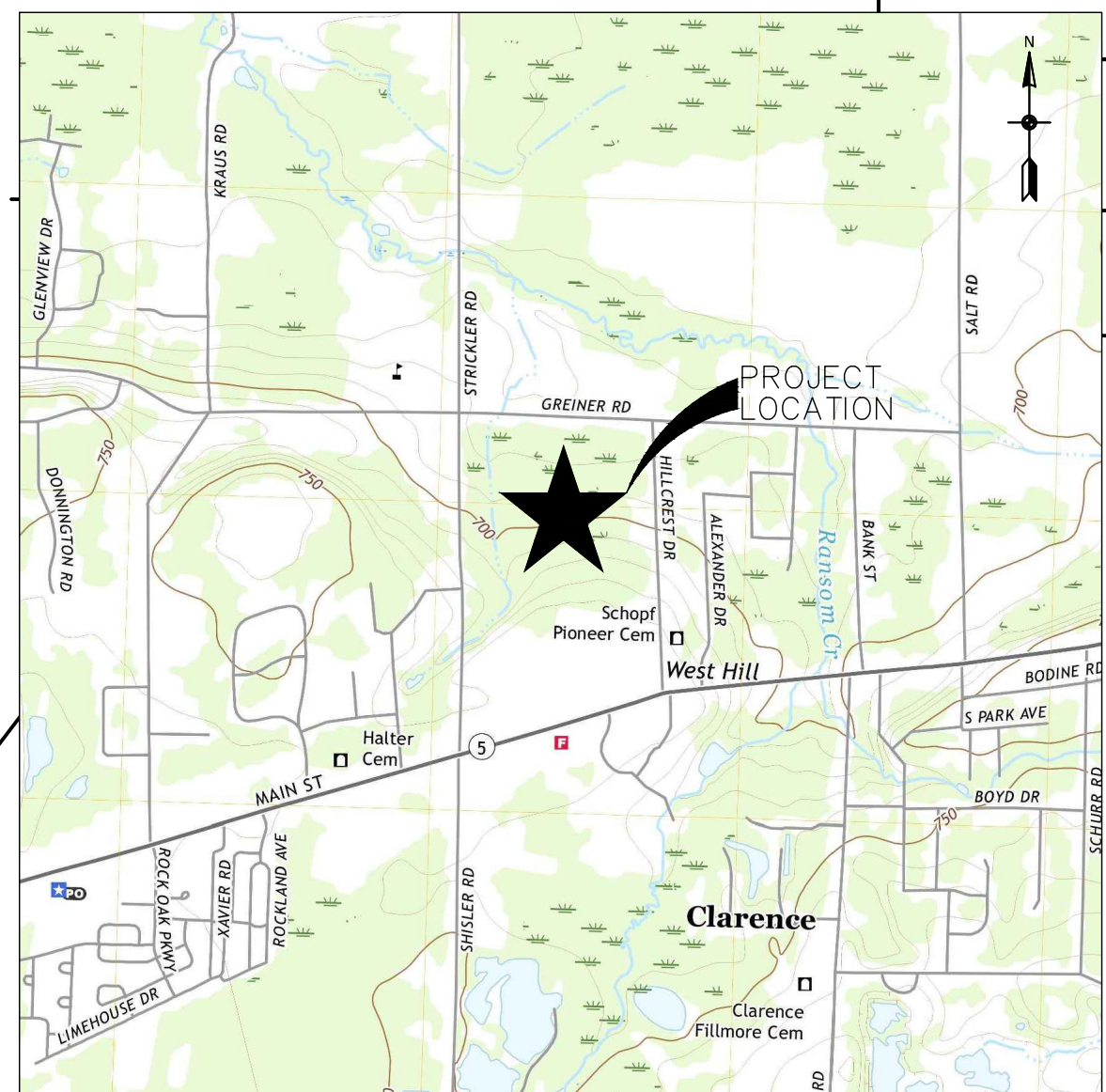

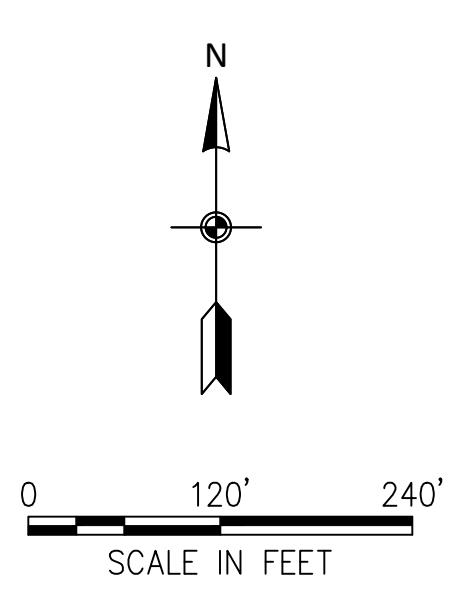


PROJECT LOCATION MAP

The Project Site is properly zoned Residential Single-Family pursuant to the Town of Clarence Zoning Map. The proposed residential subdivision has been defined broadly to include all required approvals and permits and all proposed site improvements including the proposed single-family homes, roadway improvements, on-site sanitary sewer and water infrastructure, a storm water management system, curb cuts, and all required utility connections and improvements. The proposed development will consist of 63± lots and utilizes the incentive lot to reduce lot size and maintain approximately 40% of the property as greenspace.

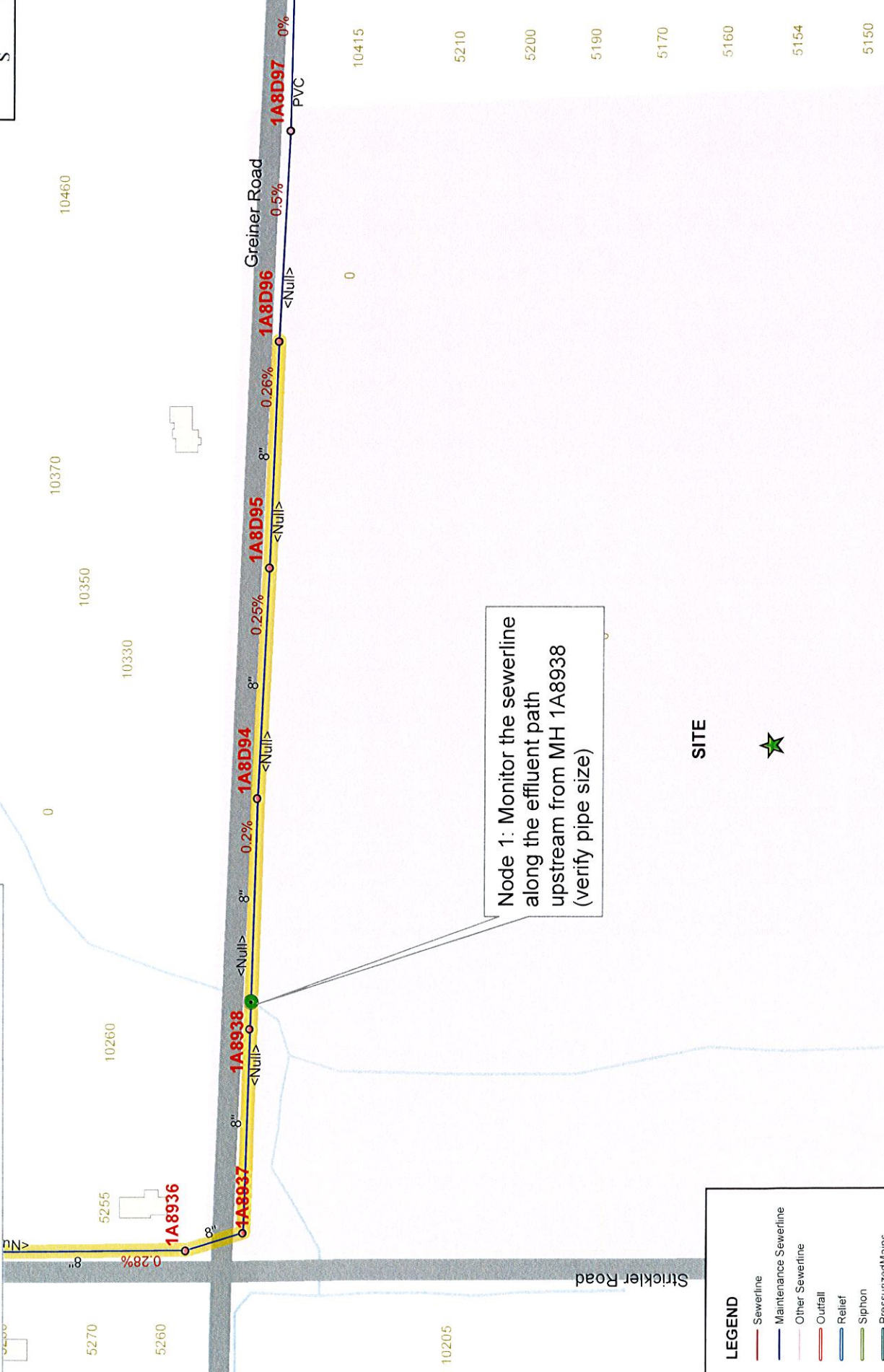
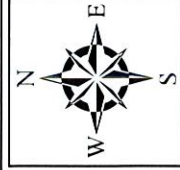
Erie County Sewers District 5 Downstream Capacity Analysis For Greiner/Strickler Development

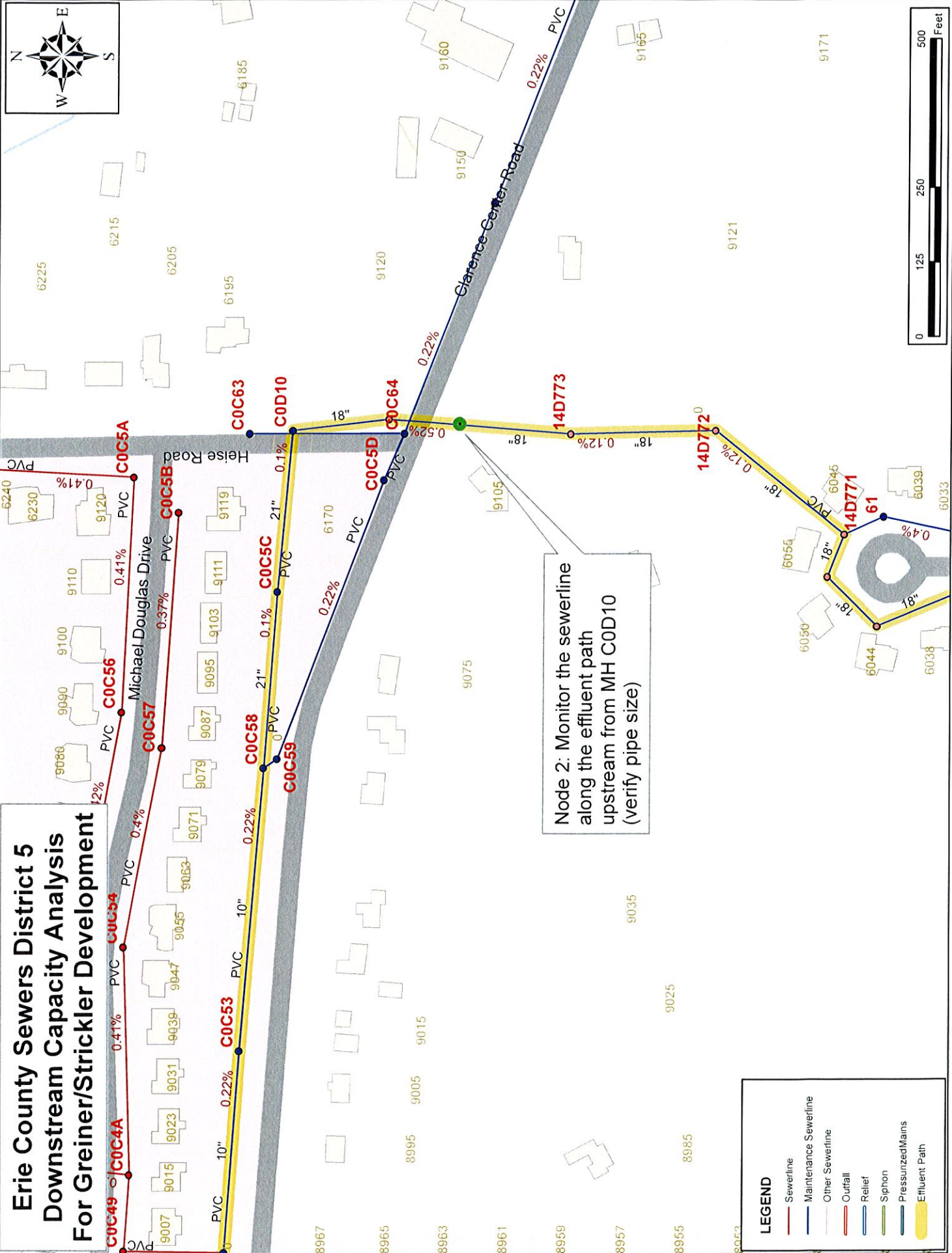
