This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby close that portion of the highway in the Town of Clarence, said County, known as Erie, and described as follows:

Closure:

The portion of Shisler Rd (CR-199) from Bergtold Rd (CR- 538) to Wehrle Dr (CR-275), the portion of Bergtold Rd (CR-538) from Ransom Rd (CR-155) to Shisler Rd (CR-199) and a portion of Ransom Rd (CR-155) from Stage Rd (CR-273) to Jones Rd will have a full road closure. Roads will be open to local traffic and emergency services only. This closure will be on September 12 from 5:30pm to 7pm or until complete. This closure is for the purpose of Oktoberfest 5k walk/race Fundraiser. Brothers of Mercy will be hosting the event.

A closure is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.

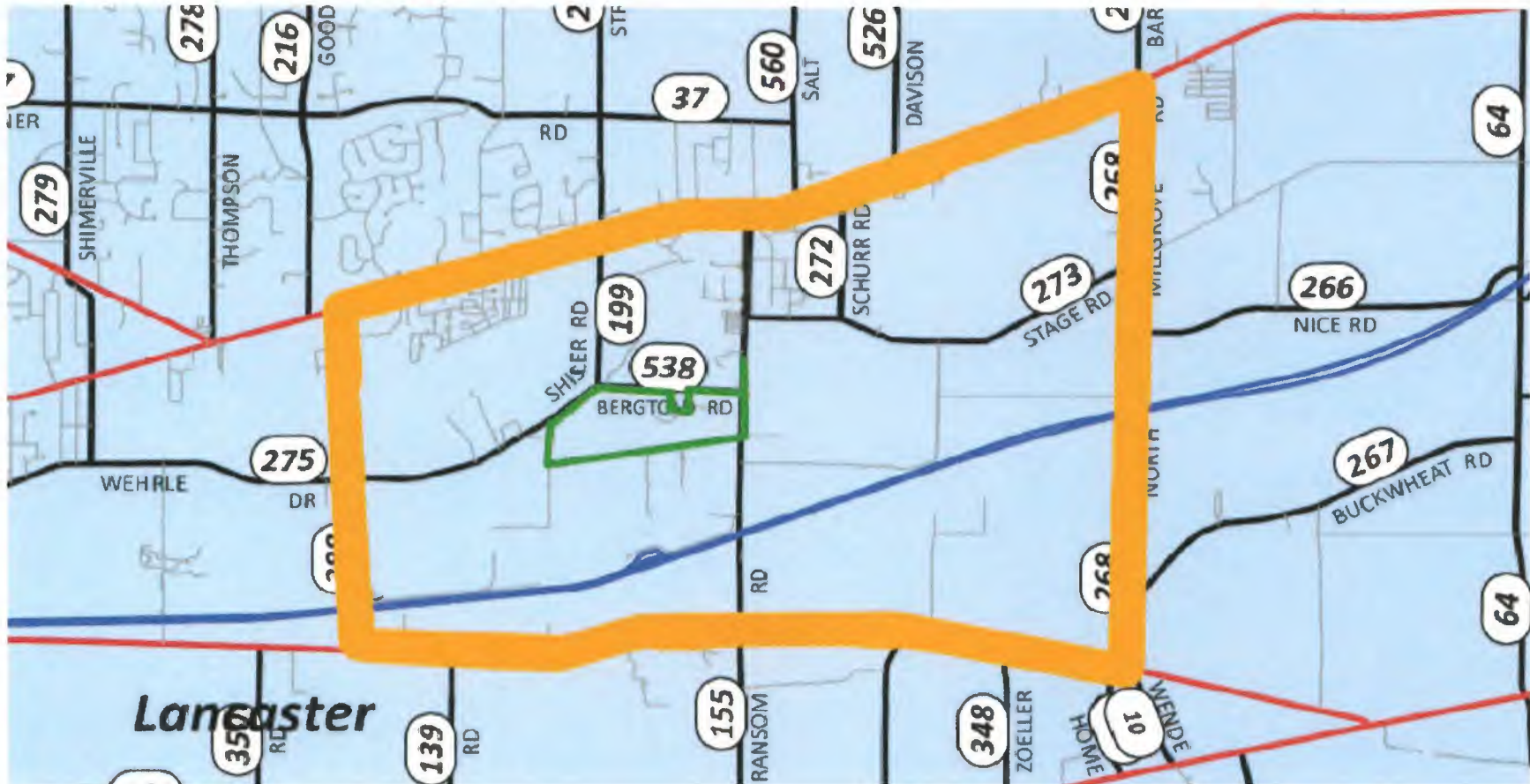
