Annual Review of Clarence 2030 – Town of Clarence Comprehensive Plan

An annual review process is required to ensure that the plan remains current. The review process may generate four types of actions:

- 1. Relevancy Update Minor text, image, map or figure changes.
- 2. Shifting Focus Alterations to strategies.
- 3. Changing Course Alterations to goals.
- 4. Varying Function Alterations to Future Land Use Map and re-zoning proposals.

There are no modifications proposed to Clarence 2030 this year. The Planning Office will provide an update on the status of the Modern Zoning Code Update. This update is being undertaken to ensure that our Zoning Code meets the intent of our Comprehensive Plan.

GMA Concrete Design

This property is located 9377 County Road on the south side of County Road and west of Goodrich Road. It's an existing 3.67-acre parcel containing a warehouse and office facility in the Industrial Business Park zone.

This will be fully fenced on the front and the side.

The applicant is requesting a Public Hearing to consider a Temporary Conditional Permit for outside business storage and operation.

Town Board has the authority to consider this request after setting and holding a Public Hearing.

WORK SESSION ITEMS:

7631 Transit Road, LLC.

This property is located at 7631 Transit Road on the southeast corner of Transit Road and Wolcott Road.

It is an existing 6.88-acre property in the Restricted Business zone. It was a complex of buildings and two residential structures. One large building remains and due to the floodway standards, a portion will be demolished to make way for an undisturbed area. The remainder of the building will remain.

The applicant is requesting preliminary Conceptual review of an approximately 36,000sqft. commercial retail building for LENCO Supplies.

Peter asks about the space in between the building and the pond. Jonathan says no current plans, but to keep it open for future use.

Patrick Casilio asks if the pond needs to be fenced. Tim Lavocat says no it just has to meet the standards for the safety requirements for the State.

The applicant, Kyle Whalen, is requesting a Public Hearing to consider a Temporary Conditional Permit for an automotive repair and performance business. The business specializes in European vehicle repair, diagnostics, tuning, and maintenance. All operations are proposed to occur within the rear warehouse. In August of 2022, the Planning Board approved the GMA Concrete Design Development Plan, subject to fourteen (14) conditions. Since then, the applicant has partially constructed the project with the original intent of operating a concrete business fully inside of the newly constructed building. Prior to project completion, the on-site operations have changed from the original intentions. GMA Concrete Design and tenant DC Landscaping & Design then filed an amended site plan that better suits the needs of the proposed operation on the site. WHEREAS, a map, plan and report in the form of a Technical Memorandum describing the project, prepared by GHD, competent engineers duly licensed by the State of New York, and supplied to the Town by the Town of Amherst, has been heretofore prepared and duly filed in the office of the Town Clerk for public examination; and

WHEREAS, the Town Board and the Town and other parties to the intermunicipal agreement have complied in every respect with all applicable federal, state and local laws and regulations regarding environmental matters, including compliance with the New York State Environmental Quality Review Act, comprising Article 8 of the Environmental Conservation Law; and

WHEREAS, the proposed area within the Town to be benefited by the proposed Sewer Improvement (herein designated and called the "Benefited Area" or the "Clarence Sewer Improvement Area"), consists of the entire area of the Town outside of any villages; and

WHEREAS, the estimated total cost of the project is \$5,060,000 and the maximum amount proposed to be expended by the Town for its allocated share of the cost of construction of the Sewer Improvement is estimated to be \$2,500,000, which is planned to be financed by the issuance of serial bonds of the Town and a charge upon the several lots and parcels of land in the entire area of the Town outside of any villages, to be levied and collected in the same manner and at the same time as other Town charges, to pay the principal of and interest on said bonds as the same shall become due and payable; and

WHEREAS, the annual cost of operation and maintenance of said Sewer Improvement shall be paid by a charge upon the several lots and parcels of land in the entire area of the Town outside of any villages which shall be levied and collected in the same manner and at the same time as other Town charges;

Now, therefore, be it

ORDERED, that the Town Board of the Town shall meet and hold a public hearing at the Town Hall, in the Town, on the 21st day of January, 2026, at 10:20 a.m. (Prevailing Time) to consider the construction of such Sewer Improvement, at which all persons interested in the subject thereof may be heard concerning the same, and for such other action on the part of the Town Board with relation thereto as may be required by law; and be it

FURTHER ORDERED, that the Town Clerk publish at least once in the Town's official newspaper(s) having a general circulation in the Town of Clarence, and hereby designated as the official newspaper(s) of the Town for such publication, and post conspicuously on the bulletin board of the Town Clerk, a copy of this Order certified by said Town Clerk, the first publication thereof and said posting to be not less than ten (10) nor more than twenty (20) days before the day set and designated herein for said public hearing as aforesaid.

On the question, Supervisor Casilio asked Town Engineer, Timothy Lavocat to give a summary.

Timothy Lavocat stated this is the parallel sewer that is to be constructed in the Town of Amherst, it has been a part of our intermunicipal agreement with the Town of Amherst for over 30 years. It is a 24-inch line from Transit to Paradise Road providing sewer capacity to achieve our goals and objectives outlining the Town of Clarence sewer projective 2030. The main goals and objectives are to abide for pollution abatement capacity and commercial development, the expansion of Clarence sewer district number nine and service existing properties within the district. The Harris Hill area, Main Street and Sheridan Drive and also Main Street and Goodrich Road. We are looking to decommission and eliminate package treatment plants at Research Parkway as well as Spaulding Lake. Additionally, this will be sewer district number 5 with the Eastern Hills Project. This is a collaborative effort between the Town of Clarence, Erie County and the Town of Amherst to provide sewer capacities to all three entities for decades to come.

Councilman DiCostanzo stated that most of the work will be conducted on the Amherst side of things until we need to connect.

Timothy Lavocat replied yes, that is correct and it is about a \$5,000,000 project total. Upon roll call – Ayes: All; Noes: None; Absent: None; Motion carried.

BOND RESOLUTION OF THE TOWN OF CLARENCE, NEW YORK, ADOPTED DECEMBER 10, 2025, AUTHORIZING THE ISSUANCE OF BONDS IN A PRINCIPAL AMOUNT NOT TO EXCEED \$6,200,000 TO FINANCE THE CONSTRUCTION OF A NEW RECREATION FACILITY, STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$6,200,000 AND APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE THE TOWN BOARD OF THE TOWN OF CLARENCE, IN THE COUNTY OF ERIE, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Town Board) AS FOLLOWS:

Section 1. The Town of Clarence, in the County of Erie, New York (herein called the "Town"), is hereby authorized to issue bonds in a principal amount not to exceed \$6,200,000 pursuant to the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called the "Law"), to finance the construction of a new recreation facility.

Section 2. The estimated maximum cost thereof, including preliminary costs and costs incidental thereto and the financing thereof, is \$6,200,000 and said amount is hereby appropriated for such purpose. The plan of financing includes the issuance of bonds in a principal amount not to exceed \$6,200,000 to finance said appropriation, the levy and collection of taxes on all the taxable real property in the Town to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 3. The following additional matters are hereby determined and declared:

- (a) The period of probable usefulness applicable to the object or purpose for which said bonds are authorized to be issued, within the limitations of Section 11.00 a. 11 (b) of the Law, is twenty-five (25) years.
- (b) The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the Town for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.
- (c) The proposed maturity of the bonds authorized by this resolution will exceed five (5) years.

Section 4. Each of the bonds authorized by this resolution and any bond anticipation notes issued in anticipation of the sale of said bonds shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds and any notes issued in anticipation of said bonds shall be general obligations of the Town, payable as to both principal and interest by general tax upon all the taxable real property within the Town. The faith and credit of the Town are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds and any notes issued in anticipation of the sale of said bonds and provision shall be made annually in the budget of the Town by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 5. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 of the Law relative to the authorization of bonds with substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes and Section 50.00 and Sections 56.00 to 60.00 and Section 168.00 of the Law, the powers and duties of the Town Board relative to authorizing bond anticipation notes and prescribing the terms, form and contents and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said bond anticipation notes, and as to the execution of agreements for credit enhancements, are hereby delegated to the Supervisor, the chief fiscal officer of the Town.

Section 6. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

(a) such obligations are authorized for an object or purpose for which the Town is not authorized to expend money, or

- (b) the provisions of law which should be complied with at the date of publication of such resolution, or a summary thereof, are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- (c) such obligations are authorized in violation of the provisions of the constitution. Section 7. This bond resolution is subject to a permissive referendum and the Town Clerk is hereby authorized and directed, within ten (10) days after the adoption of this resolution, to publish or cause to be published, in full, in the official newspaper of the Town, having a general circulation within said Town, and posted on the sign board of the Town maintained pursuant to the Town Law, a Notice in substantially the following form appearing in Exhibit A hereto.

Section 8. The Town Clerk is hereby authorized and directed, after said bond resolution shall take effect, to cause said bond resolution to be published, in summary, in the official newspaper of the Town, having a general circulation within said Town, together with a Notice in substantially the form as provided by Section 81.00 of the Law.

On the question, this is a Sourcewell Contract and Fund Balance will be allocated in the 2026 Budget to line 2.5110.279 Other Equipment which will be reimbursed upon the Highway Equipment Bond borrowing that will occur in 2026.

Councilman DiCostanzo mentioned per the October 2025 report, we had ten single family residential permits bringing the yearly total to 67 houses.

Councilman Michnik mentioned Joe McGreevy will be putting on display in the Town Hall lobby what the Town of Clarence seal represents to the Town. Thank you to Joe for all the extra hard work he has put into putting this project together.

Councilman Altieri mentioned the Clarence Chamber is working on the annual Gala as well as the Golf Outing for everyone to plan to attend.

On the question, approval for the Fireworks Display Permits is subject to receipt of all the appropriate paperwork, fees, insurances and fire chief approvals are on file in the Planning and Zoning office.

Annual Review of Clarence 2030 - Town of Clarence Comprehensive Plan With the adoption of Clarence 2030 on December 14, 2016, an annual review process is required to ensure that the plan remains current. Per the Plan, the annual review process may generate four types of actions:

- Relevancy Update Minor text, image, map or figure changes.
- Shifting Focus Alterations to strategies.
- Changing Course Alterations to goals.
- Varying Function Alterations to Future Land Use Map and re-zoning proposals.

There are no modifications proposed to Clarence 2030 this year. We continue to develop a Modern Zoning Code that reflects the intent and direction of Clarence 2030.

Supervisor Casilio stated that this is very important, and to us as the Town Board, we have an interest in cleaning up a lot of the Town Codes with property violations as we are out almost daily trying to handle them all. Once this process is all done, we will have a better code to serve people with in the Town of Clarence.

Councilman DiCostanzo stated that some of this seems trivial but this is very important to us. If we let the little things go then the next thing you know the Town starts looking like garbage so we are trying to hold peoples feet to the fire.

Motion by Councilman DiCostanzo, seconded by Councilman Altieri to approve the bill pay of December 4, 2025 as follows: General Funds \$973,557.92; Highway Funds \$459,551.60; Water Funds \$922.00; Sewer Funds \$508.34 and Capital Funds \$103,728.22 for a total bill pay of \$1,538,268.08.

On the question, Councilman DiCostanzo stated that the General and Highway are so big because they have to pay the pension contribution to the State and we get a discount to pay early. Upon roll call – Ayes: All; Noes: None; Absent: None; Motion carried.

Renee Reade, a resident, was present providing pictures of her property for the Board to view. She mentioned that she received notification according to Sheridan Drive Improvement Plan stating that sidewalks would be placed on their property behind their house. I am here to represent my family and present the history of the trees on our property and why they are there. Renee presented the history of the property and how the State deemed Transit Road and Sheridan Drive dangerous and implemented a ramp. When this was completed, my mom wanted to beautify the ramp and planted many trees on our property. Fast forward to today and the 2030 plan they now want to take these beautiful trees down that are 40 or 50 years old which provide many benefits.

Supervisor Casilio stated that he can not speak of the design team, but this is part of the connect the dots on this project. I do remember all of this history that you mentioned.

Timothy Lavocat stated that we spoke on the phone earlier this week and I sent you the drawings that I am assuming your received. The NYS DOT requires us to do the sidewalk on both sides of the ramp for connectivity. This was a condition of the grant so there will be sidewalks on both sides of the ramp. Although there may not be foot traffic there today, there is a proposal for the Eastern Hills mall for 1600 residential units, this is a project for the future. No trees are being taken down on private property, the proposal is that those trees are in the DOT right of way and we would work with you to see what could be preserved. The problem is we have a large area there, a ditch that needs to be filled with a fair amount of work to be done. I was out there yesterday and the three pine trees that are closer to Sheridan Drive to be removed that are not great, the tops are dead as well as the backs and again they are in the highway right of way. They are on there way to being a hazard more that a benefit at this point. We can take a look in other locations however the state DOT has regulations and distances that we have to follow for safety issues. The plans that I sent you have been back and forth about thirteen times with NYS DOT to meet their standards. I would be happy to meet with you to go through this with you.

Supervisor Casilio asked if the state takes trees down will they give them back and replant.

Timothy Lavocat stated that is a local decision. It is possible but we would still need DOT approval.

Renee Reade asked if the Town of Clarence was the one to initiate the project how do we go to having to comply with the state requirements.

Timothy Lavocat stated that this is a Federal Grant that is applied with through the DOT and in conjunction with them with Federal and State funds with Town matching share as well. There have been many motions and meetings since 2021 pertaining to these plans.

Renee Reade stated that this is just a complete shock to me and my family.

Supervisor Casilio replied that he does feel your pain as I love trees as well and I thank you for coming in today.

With no further business, Supervisor Casilio adjourned the meeting at 10:58 a.m.
