







### Land

Protect farmland, increase residential setbacks, and streamline review of neighborhood businesses.

### Product

Require premium building materials, and increase landscaping quantity and variety.

### Process

Simplify code structure, and make review process adaptable and understandable.

### Authority

Define enforcement mechanisms and create administrative penalties.



### Zoning Code Meeting







## Clarence Hollow Farmers Market



### CABOOSE STRUCTURE

Feature structure near the southwest entrance provides opportunity for event expansion and site theming.



### BATHROOM FACILITIES

Restrooms that match the atmosphere of the site and therefore enhance the space by creating a continuous feel. Potential shade structure in the front.



### THEMED BAND STAND

Open-air pavilion inspired by historic train depots, providing flexible year round space for musicians and vendors and visitors while reinforcing the site's heritage character.



### HARDSCAPE / CONCRETE

Strategically implemented unique paving / stamped concrete at pedestrian entrances. Concrete can be stamped to look like train tracks and can be painted / stained for a more intricate look.



### ESCARPMENT STAIRCASE

Feature stair integrated into escarpment to create vital new pedestrian link, as well as an attractive gateway with seating, overlook, and interpretation opportunities.



### SEASONAL STORAGE OPTIONS

Secure container on wheels / box car for seasonal market equipment, designed for easy access and off-season storage. The exterior can be enhanced with a community-driven mural to add color, identity, and year-round visual interest.



### ESCARPMENT TRAIL MARKET

Trail leads to programmed temporary "villages" for people to enjoy immersive experiences with a highlight in fall interest.



### BATHROOM FACILITIES

Restrooms that match the atmosphere of the site and therefore enhance the space by creating a continuous feel.



### COVERED SEATING AREAS

Strategically implemented shaded seating can provide a sense of security and gives the opportunity to align with other site structures.



### THEMED ART INSTALLATION

Areas for permanent or temporary large-scale art installations that can define the site or an upcoming event.



### PLANTERS FOR ACCESS CONTROL

Flexible bollards and planters define Market Row areas, guide circulation, and allow for quick transformation between market and community uses in other areas of the site.



### WOODLAND VIEWING DECK

Elevated deck offering views into the adjacent wooded area, providing trail access and creating a peaceful retreat from the market's activity.


