Updating Your Address with the New York State Department of Motor Vehicles

- If you have a New York State driver license, learner permit or non-driver ID card, or a registration for a vehicle, boat or snowmobile, you are required by law to notify DMV within 10 days of any PERMANENT address change. Do NOT report temporary changes (such as school or military addresses).
- You can change your address online at: www.dmv.ny.gov, or use this form.
- Write your new address on your current state or enhanced license, permit, or non-driver ID card and/or registration document.
- If your state or enhanced license, permit, non-driver ID card or registration will expire within the next 75 days, call DMV (see phone numbers listed below) for information about changing your address and renewing your document by mail at the same time.
- Motor Vehicles does not require you to get a new license, permit, non-driver ID card or registration document, but many people prefer to do so. To purchase a replacement document(s) complete Parts 1 and 2 on Page 2.
- If you request an enhanced license, permit, or non-driver ID document, your residence address will appear on your document (and the document will be mailed to your mailing address). If you request a non-enhanced document, your mailing address will appear on your document. Keep your current document(s) until you receive a new one(s) in the mail (allow 4 to 6 weeks for delivery).
- If you DO NOT want a new document(s), simply leave Part 2 on Page 2 blank. DMV will update your DMV records at no cost to you.
- If you have moved to New York from someplace outside of the state, and want information about obtaining a New York State driver license, permit, non-driver ID card (or enhanced version of these documents) and /or a registration document, visit the DMV website: www.dmv.ny.gov or call DMV (Monday to Friday, 8:00 am to 4:00 pm):

- If you have unpaid Traffic Violation Bureau (TVB) tickets, in addition to reporting your address change on this form, you must call TVB to report your address change and make arrangements to pay your traffic ticket fines. For NYC and Suffolk County TVB call Offices:(718) 488-5710. For Buffalo and Rochester TVB Offices call: (518) 474-0941.

If you do not complete the NYS Voter Registration Application, you will be considered to have declined to register to vote. If you decline to register, your decision will remain confidential. If you believe that someone has interfered with your right to register or decline to register to vote, your right to privacy in deciding whether to register or in applying to register to vote, or your right to choose your own political party or other political preference, you may file a complaint with the NYS Board of Elections, 40 Steuben Street, Albany, NY 12207-2109 (phone: 1-800-469-6872).

Your completed application will be sent to the Board of Elections and you will be notified by your County Board of Elections when your application has been processed. If you have any questions about filling out the voter registration application or registering to vote, you should call your County Board of Elections or call 1-800-FOR-VOTE (TDD/TTY Dial 711) (only for voter registration questions).
