WHEREAS, under U.S. Government Accountability Office Government Auditing Standards, the Erie County Comptroller's Office is required to conduct an external quality review of its Division of Audit and Control; and

WHEREAS, the last such review of the Division of Audit and Control was completed in January 2010 for the period January 1, 2006 to December 31, 2008; and

WHEREAS, on June 1, 2012, this office released a request for proposals ("RFP") and disseminated such request to twenty one (21) accounting firms; and

WHEREAS, upon the close of the response period on July 13, 2012, six (6) firms responded to the RFP, up from four in 2009; and

WHEREAS, following a review of the responses from Amato, Fox & Co. PC, Clifford Accounting Services, LLC, Freed Maxick; Buffamante Whipple Buttafaro; The Bonadio Group; and Honkamp Krueger, our office selected The Bonadio Group, a professional services accounting and auditing firm which conducted the County's external quality review in 2007; and

WHEREAS, in order to start the review, and pursuant to Section 19.08 of the Erie County Administrative Code, legislative approval of a contract/engagement letter with The Bonadio Group is necessary.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby approve the Erie County Comptroller's engagement of The Bonadio Group to perform an external quality review of the Comptroller's Division of Audit and Control at a cost of no more than \$8,000; and be it further
