## 3. COMM. 19E-7 (2018)

## **COUNTY EXECUTIVE**

WHEREAS, the New York State Office of Indigent Legal Services provided a three year grant totaling \$1,350,000 to the County for the development and operation of a Regional Immigration Assistance Center with the provision of legal support, assistance, training and education services to indigent defense providers, and

WHEREAS, Erie County contracted with the Erie County Bar Association Volunteer Lawyers Project, Inc. to deliver the services required through the grant, and

WHEREAS, the New York State Office of Indigent Legal Services has agreed to extend the contract tem for an additional one year period to allow the agency to complete the terms and conditions of the grant.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to enter into a contract amendment with the State of New York Office of Indigent Legal Services, extending the contract term for an additional one year period of November 1, 2018 to October 31, 2019; and be it further

RESOLVED, that the County Executive is hereby authorized to enter into a contract amendment with the Erie County Bar Association Volunteer Lawyers Project, Inc. extending the contract term for an additional one year period of November 1, 2018 to October 31, 2019; and be it further

RESOLVED, that authorization is provided to extend the grant period of 160RAIC1518 in the County Attorney's Office to October 31, 2019; and be it further

RESOLVED, that the Director of Budget and Management is hereby authorized to adjust items of appropriations and revenues which may be impacted by changes to the grantor award, provided there are no changes to authorized personnel levels and county share amounts: and be it further
