WHEREAS, without admitting or denying liability, the prior County administration signed a Consent Decree with the US Department of Justice in 2011 settling litigation filed against the County by the United States of America involving alleged violations of the Resource Conservation and Recovery Act and the Clean Water Act; and

WHEREAS, the Consent Decree was certified by the federal judge overseeing the case on March 4, 2012 and the civil penalty requires the County remit the payment via electronic funds transfer by April 4, 2012; and

WHEREAS, the civil penalty totals \$155,000 for the Clean Water Act, and the civil penalty totals \$120,000 for the Resource Conservation Recovery Act; and

WHEREAS, the Consent Decree was signed by then-County Attorney Jeremy Colby in 2011;

WHEREAS, this settlement shall post as a 2011 expense of the County, based on the 2011 agreement; and

WHEREAS, funding is available within the 2011 budget of the Department of Public Works' Division of Buildings and Ground;

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby authorizes the payment of the \$275,000 civil penalty in this matter and the Division of Budget and Management is hereby authorized to adjust the Adopted 2011 Budget of the Division of Buildings and Grounds as follows:
