RESOLUTION NO. 10 Re: Support for ECMC Proposal for Hospital & Physician Care for Inmates in Western New York (Int. 2-1)

WHEREAS, in August, 1996, the ECMC responded to a RFP for Hospital and Physician Specialty Care for Inmates in WNY (Hub 8) issued by the New York State Department of Correctional Services (NYS DOCS) and

WHEREAS, ECMC was one of nine respondents to the RFP, and

WHEREAS, ECMC is the current provider for the majority of hospital, physician and specialty care for NYS DOCS and had established a relationship with the State of New York for the past ten years, and

WHEREAS, one of the major requirements of the RFP was for the respondents to outline a network of hospitals and specialty physicians along with the designation of a tertiary hospital and that ECMC does, in fact, meet this requirement as it is only one of three tertiary care providers in Western New York, and

WHEREAS, in October, 1996, ECMC was advised that its proposal had not been selected, but rather the proposal of Correctional Physician Services, Inc. (CPS) of Blue Bell, Pennsylvania, was chosen, and

WHEREAS, it has come to the attention of ECMC that CPS is experiencing difficulty in putting together a network of physicians and health care institutions necessary to fulfill the requirements of its proposal,

NOW, THEREFORE, BE IT

RESOLVED, that this Honorable Body requests the NYS DOCS to determine if CPS can, in fact, fulfill the requirements of its proposal, and be it further

RESOLVED, that this Honorable Body requests the NYS DOCS, if upon determining that CPS cannot fulfill its proposal or has so amended its proposal as to constitute a new proposal, reject its proposal and permit the other respondents to submit amended or enhanced proposals, and be it further

RESOLVED, that this Honorable Body strongly supports the proposal of ECMC as being the best-suited and most cost-effective for the NYS DOCS and state taxpayers, and be it further

RESOLVED, that a copy of this resolution be transmitted Governor George Pataki, members of the Western New York State Delegation and the Commissioner of the NYS Department of Correctional Services, and Paul Candino, Chief Executive Office, ECMC.

RESOLUTION NO. 11 Re: Section 8 Housing (Int. 2-2)

WHEREAS, The Belmont Shelter Corporation has a contract with Erie County to administer the local share of the Department of Housing and Urban Development's Section 8 subsidized housing program, and

WHEREAS, The Rental Assistance Center administers HUD's Section 8 program in the City of Buffalo, and

WHEREAS, A City of Buffalo resident recently complained to a Federal judge that she was the victim of racial discrimination at the hands of the Belmont Shelter Corporation, and

WHEREAS, The complainant alleged that the Belmont Shelter Corp. refused to provide her with a list of suburban apartments that are available for Section 8 participants, and

WHEREAS, Officials at Belmont supposedly refused the client a list of available suburban properties because, due to her current address, she was a client of the Rental Assistance Center, and

WHEREAS, There is a seven-year-old public housing discrimination lawsuit in U.S. Federal Court involving the Belmont Shelter Corp. and the Department of Housing and Urban Development, and

WHEREAS, The lawsuit claims that minorities with HUD subsidies have been "steered" to city dwellings, while whites had an easier time securing suburban apartments, and

WHEREAS, The Buffalo metropolitan area is the fourth most segregated area in the country, and

WHEREAS, Erie County's suburbs are 95% white, and

WHEREAS, 6,976 families in Erie County receive government assistance to rent private apartments under HUD's Section 8 program, and

WHEREAS, Though 21% of applicants for suburban vouchers were black, only 3% of those getting suburban apartments were minorities, and

WHEREAS, HUD has announced that the Belmont Shelter Corp. is changing its policy so that anyone who qualifies for federal rent subsidies can receive a list of suburban properties, regardless of current address.

NOW, THEREFORE, BE IT

RESOLVED, That the Erie County Legislature believes that every resident of Erie County should have access to any housing which is subsidized by the federal government, and be it further

RESOLVED, That this Body invites the Belmont Shelter Corp. to meet with this Legislative Body to discuss a) the specific incident mentioned above, b) the ongoing federal lawsuit, and c) the possibility of merging with the Rental Assistance Center so that there is one agency administering Section 8 funds in the City of Buffalo and Erie County, and be it further

RESOLVED, That certified copies of this resolution be forwarded to the Belmont Shelter Corp.; the Rental Assistance Center; Judge John Curtin; Sharon Smith; James Morrissey, director of the Western New York Law Center; Ellen Yacknin, the Greater Upstate Law Project; and the Western New York offices of the Department of Housing and Urban Development.

WHEREAS, a copy of these three (3) Agricultural Districts maps are on file in the County Clerk's office and the Eden, Hamburg, Orchard Park, and Boston Town Halls and North Collins Municipal Office.

RESOLVED, that the Clerk of the Legislature be directed to publish a public notice in a newspaper having general circulation within the area of the above agricultural districts, that notice be posted in at least five conspicuous places within the districts, and that notice also be sent to the affected municipalities, being the Towns of Eden, Hamburg, Orchard Park, Boston and North Collins, and be it further

RESOLVED, that after this 30 day period, the Legislature hereby directs the Clerk to refer the Eden Valley, Eden Boston and Eden Langford Agricultural Districts to the Erie County Department of Environment and Planning and the Agricultural and Farmland Protection Board for a report and recommendations, and be it further

WHEREAS, this funding may be provided by the County of Erie to local community based organizations and agencies for the purposes of assisting our youth or senior citizens, and to assist in crime fighting, emergency services, or other types of neighborhood based service delivery, and

WHEREAS, the Legislature must pass an enabling resolution such as this to effect this transfer of funds,
