Re: Opposition to State Action Penalizing City, Town & Village Governments in Traffic Plea Bargaining. (Intro. 19-1)

A RESOLUTION SUBMITTED BY LEGISLATOR WROBLEWSKI

WHEREAS, for decades, local judicial authorities in towns and villages across New York State have routinely allowed certain individuals, cited for specific traffic moving violations, usually speeding, to plea bargain and to plead guilty to non-moving violations such as parking violations, and

WHEREAS, through that action, and the change of citation and conviction from a moving to a non-moving violation, the local governments have been able to retain the fine levied against the individuals and use such revenue in their budgeting, and

WHEREAS, such an action benefits the local government through the receipt of revenue, and such an action benefits the drivers through the ability to avoid a recorded mark on their driving record and correspondingly higher automobile insurance premiums, and

WHEREAS, in the 2004-2005 New York State Budget, approved recently by the State Legislature and signed into law by the Governor, such fees, which take effect on September 1, 2004, would no longer go to the local municipalities, but to the State, and

WHEREAS, according to published reports, that action would shift between \$12 million and \$22 million in annual recurring revenue from local governments to the State – yet another instance of the State imposing punitive mandates on local governments, and

WHEREAS, according to local government and judicial authorities, the loss of such revenue would lead to higher property taxes in towns and would lead local governments to create new localized traffic surcharges and fines to recoup the revenue, reflected for instance, in the recent action by the Village of Alden Board to approve a \$10 surcharge on violations,

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its opposition to this State action – the latest in a series of punitive State mandates that penalize and harm local governments – and calls on the State Legislature and Governor George Pataki to revisit this rule change once they reconvene in September 2004 and to terminate the measure, and be it further

RESOLVED, that certified copies of this resolution be transmitted to Governor George Pataki, Assembly Speaker Sheldon Silver, Senate Majority Leader Joseph Bruno, to the local delegation of the New York State Legislature, and to the supervisors/mayors and town/village boards of each municipality in Erie County.

A RESOLUTION SUBMITTED BY LEGISLATOR MARSHALL

WHEREAS, *Heracleum Mantegazzianum*, which is commonly referred to as "Giant Hogweed", is infesting riparian areas, abandoned lots, right-of-ways and roadsides in Erie County, and

WHEREAS, *Heracleum Mantegazzianum*, which is indigenous to the Caucasus Mountains and southwestern Asia, was transported to the United States in the early 20th century as a unique garden plant, and

WHEREAS, Giant Hogweed escaped containment in private gardens and naturalized in many states, including: Massachusetts, Pennsylvannia, Washington and New York, and

WHEREAS, *Heracleum Mantegazzianum* is a member of the parsley family and in some ways resembles the native and non-threatening *Heracleum lanatum* (commonly referred to here as Cows Parsnip), which can be found readily in Erie County, and

WHEREAS, Giant Hogweed is distinguished from Cows Parsnip by its 2 to 4 inches in diameter stem that has dark purple markings, as well as by its ability to grow to a heights of 10 to 15 feet when in flower, and

WHEREAS, Giant Hogweed is on the Federal as well as many state's noxious weed lists because it presents a serious public health risk to those who come in contact with the clear watery sap found on the plants stem and leaves and the ultraviolet rays of the sun, and

WHEREAS, individuals that do come in contact with Giant Hogweed and the sun suffer symptoms that include severe skin irritation, including blistering equivalent to a second degree burn and permanent scaring, and

WHEREAS, the public must be made aware of the threat of coming in contact with Giant Hogweed and the County of Erie has an obligation to eradicate Hogweed from all county land,

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature is committed to addressing issues of public safety and public health, and be it further

RESOLVED, is committed to working with the New York State Department of Agriculture and Markets and the Cornell Extension to monitor all areas affected by Giant Hogweed in Erie County and make that information readily available to the public, and be it further

RESOLVED, that this Honorable Body supports efforts by the Erie County Department of Public works efforts to eradicate Giant Hogweed from all county land, and be it further

Re: Opposition to Proposed Reductions in Federal Section 8 Housing Program. (Intro. 19-13)

A RESOLUTION SUBMITTED BY LEGISLATORS DEBENEDETTI, MARINELLI AND SMITH

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) maintains a federal housing choice flexible voucher program, known as Section 8, the federal government's major program for "assisting very low-income families, the elderly, and the disabled to afford decent, safe, and sanitary housing in the private market," and

WHEREAS, under the program, housing assistance is provided on behalf of the family or individual, participants are able to find their own housing, including single-family homes, townhouses and apartments, with the participant free to choose any housing that meets the requirements of the program and is not limited to units located in subsidized housing projects, and

WHEREAS, housing choice vouchers are administered locally by public housing agencies, with the housing agencies receiving federal funds from HUD to administer the voucher program, and

WHEREAS, "a family that is issued a housing voucher is responsible for finding a suitable housing unit of the family's choice where the owner agrees to rent under the program. This unit may include the family's present residence. Rental units must meet minimum standards of health and safety," and

WHEREAS, "a housing subsidy is paid to the landlord directly by the public housing authority on behalf of the participating family. The family then pays the difference between the actual rent charged by the landlord and the amount subsidized by the program. Under certain circumstances, if authorized by the public housing authority, a family may use its voucher to purchase a modest home," and

WHEREAS, in Erie County, almost 11,000 families across all towns and cities have access to safe, secure housing through the Section 8 voucher program administered by the Rental Assistance Corporation and Belmont Shelter Corporation, and

WHEREAS, the program benefits tenants, landlords and the community through the placement of individuals into rental apartments across the area, and

WHEREAS, according to U.S. Senator Charles Schumer, President Bush's proposed Fiscal Year 2005 budget cuts federal spending for Section 8 vouchers by \$1.6 billion, and by \$4.6 billion by FY 2009, and

WHEREAS, according to Senator Schumer, the administration's proposal would lead to the loss of \$5.85 million in voucher funding in Erie County alone, with as many as 1,322 families potentially losing vouchers and resulting in a net monthly rental increase to each family of \$536, and

WHEREAS, Senator Schumer has introduced legislation in the form of an amendment to the FY 2004 Veterans Affairs and HUD Appropriations Act in order that Section 8 vouchers would be funded by the current method,

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for the HUD Section 8 voucher program that provides affordable, safe housing for 11,000 families in this county, and urges the President to propose and accept a FY 2005 budget that maintains the existing HUD formula for flexible choice vouchers, and be it further

RESOLVED, that certified copies of this resolution be transmitted to the President, local congressional delegation, HUD Secretary Alphonso Jackson (451 7th Street S.W., Washington, DC 20410), Mary Shine of Rental Assistance Corporation (470 Franklin Street, Buffalo NY 14202), and Elizabeth Huckabone of Belmont Shelter Corporation (1195 Main Street, Buffalo, NY 14209).

WHEREAS, if the FMAP provision was not adopted by Congress and signed into law by the President, New York State would lose \$1.47 billion in federal Medicaid funds, the highest amount of any state or territory in the country, and

WHEREAS, reauthorization of the FMAP rate is necessary as the last increase of 2.95% for New York State expired on June 30, 2004, and

WHEREAS, United States Representative Peter King has introduced similar legislation (H.R.4961), the Medicaid Act of 2004, providing for a 1.6% increase in the FMAP,

WHEREAS, the loss of such federal funding would likely lead the New York State government to pass along the additional costs of Medicaid to local county governments at a time when county governments in this state are already unduly burdened by Medicaid and Family and Child Health Plus costs,

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for the Medicaid FMAP legislation introduced by Senators Rockefeller and Smith and Representative King, and calls on all members of the United States Senate and United States House of Representatives to expeditiously approve legislation to continue the FMAP for New York State and all states at the highest possible percentage possible, and be it further

RESOLVED, that this Honorable Body commends Senator Charles Schumer for cosponsoring S.2671, and urges Senator Hillary Rodham Clinton to co-sponsor S.2671, and be it further

County of ERIE as follows:

Section 1.

Pursuant to Section 252-a of the Family Court Act, the Erie County Department of Probation and Youth Detention Services, when ordered by the courts to conduct an investigation pursuant to section 653 of the Family Court Act, is authorized to charge and is entitled to receive a fee of not less than fifty (\$50) dollars and not more than five hundred (\$500) dollars from the parties in the proceeding to help reimburse the cost of the investigation conducted by the department.

Section 2.

Such fee shall be based on the party's ability to pay the fee and the schedule for payment shall be fixed by the court issuing the order for investigation, pursuant to the guidelines issued by the director of the division of probation and correctional alternatives, and may in the discretion of the court be waived when the parties lack sufficient means to pay the fee. The court shall apportion the fee between the parties based upon the respective financial circumstances of the parties and the equities of the case.

Section 3.

In the event of non-payment of the investigation fee, the County may seek to enforce payment in any manner permitted by law for the enforcement of a debt.

Section 4.

Fees collected pursuant to this Local Law shall be paid directly to the Erie County Department of Probation and Youth Detention Services to be retained and utilized for probation department services and staffing, and shall not be considered by the division of probation and correctional alternatives when determining state aid reimbursement pursuant to Section 246 of the Executive Law.

- b) EUGIBLE COUNTY EMPLOYEE All full and part-time employees who are on the active payroll of Erie County government, with the exception of Commissioners, Department Heads, Deputy Commissioners or supervisory employees who job responsibilities call for them to seek methods to improve operations and services.
- c) EMPLOYEE SUGGESTION REVIEW COMMITTEE There shall be an Employee Suggestion Review Committee made up from the Commissioner or their designee from the affected County department, Unit Supervisor, and a department clerical person to track and maintain suggestions and records. Representatives from the Budget Department and a Union Representative will be notified of the meeting and results, but are not required to attend.
- d) EMPLOYEE SUGGESTION AWARD COMMITTEE There shall be an Employee Suggestion Award Committee made up from the Deputy County Executive, affected department Commissioner, Labor Director, Budget Director or their representative and a staff member to maintain records and/or decisions.

Section 2. PROCEDURES

- a) All suggestions shall be submitted on an Employee Suggestion Program Form that has been properly signed and date/time stamped and shall become the exclusive property of the County of Erie. All decisions of the Review Committee and Award Committee shall be final, binding, non-reviewable and non-grieveable, except as provided by the rules and regulations promulgated by the Review Committee and Award Committee under Section 4.
- b) The Review Committee shall have the following powers and duties: to receive and review all suggestions submitted by eligible County employees within 45 days of Employee Suggestion Program Form submission; approve and coordinate the implementation of adopted suggestions; notify the employee of committee's decision; and make recommendations to the Award Committee.

- c) The Award Committee shall have the following powers and duties: review results of the implementation period; and determine and approve awards and recognitions. The decisions are final and binding -all decisions are non-grievable.
- d) Members of the Review Committee and Award Committee shall not receive any additional salary or compensation for service as members of these committees.

Section 3. AWARD TO EMPLOYEES

- a) Awards will be based upon the benefit they bring to Erie County. All eligible implemented suggestions will receive consideration for some form of recognition.
- b) The minimum monetary award for a suggestion with either tangible savings or intangible savings will be \$50. There is no maximum amount. The employee can receive 10% of the first year's savings without limit.
- c) Payment will be made to the employee upon verification of annual savings by the Budget Director. The process may take up to one year.
- d) If adoption of a suggestion results in savings to one unit but a loss to another unit, the savings would be offset by the loss. Therefore, no monetary award shall be given in this instance.
- e) Eligible County employees may make joint suggestions with other eligible County employees; however, any award will be divided equally among the employees submitting the suggestion.

Section 4. RULES AND REGULATIONS

a) The Review Committee and the Award Committee shall make such rules and regulations as are lawful, necessary and appropriate for the proper administration of this program as it applies to their respective powers and duties, subject to the provisions of this Local Law, provided that the Legislature, by simple majority, has not voted to disapprove such rules or regulations within sixty (60) days from the Review Committee and the Award Committee's written notice to the Legislature that such rules or regulations have been promulgated.
