COUNTY OF ERIE
Local Law No. _____-2004
Local Law Intro. No. 11- 2004

A LOCAL LAW defining special or outside counsel and lobbyists, and requiring their disclosure and hiring only after a request for proposal (RFP) has been conducted, and prior approval granted by the Erie County Legislature.

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF ERIE, AS FOLLOWS:

Section 1. Short Title.

This Local Law may be cited as the "Erie County Lobbyist and Counsel Responsibility Law."

Section 2. Legislative Intent.

The Erie County Legislature hereby finds, declares and determines that increasingly special or outside legal counsel, and/or lobbyists are being retained by the Executive Branch of County government with little or no legislative oversight of the activities of these persons engaged in these activities, knowledge of their identity, their method of retention, or cost to the taxpayers. Local legislation is necessary in order to provide appropriate legislative oversight of these matters, including policy review and cost containment.

Section 3.

As used in this Local Law, all terms and words shall have the meanings as defined in Chapter 32 of the Consolidated Laws of the State of New York, otherwise known as the Legislative Law (Lobbying Act).

- a. The term "lobbyist" shall mean every person or organization retained, employed or designated by Erie County to engage in lobbying. The term "lobbyist" shall not include any officer, director, trustee, employee, counselor agent of New York State, or any municipality or political subdivision contained therein when discharging their official duties; except those officers, directors, trustees, employees, counsels, or agents of colleges, as defined by section two of the education law.
- b. The term "special counsel" or "outside counsel" shall mean any attorney or law firm retained by the Executive Branch, the Legislative Branch, any elected or appointed officer or employee of Erie County, including the County Attorney, to carry on lobbying or legal activities, or representation and/or advocacy on behalf of Erie County.
- c. Erie County shall mean the municipal corporation of Erie County, New York and all its officers, agents and employees, whether elected or appointed, in the Executive Branch, the Legislative Branch, and any other County Board, agency or committee.
- d. The term "lobbying" or "lobbying activities" shall mean any attempt to influence the passage or defeat of any legislation at either the local, State or Federal level of government; or the adoption or rejection of any rule or regulation having the force and effect of law or the outcome of any rate making proceeding by any local, State or Federal agency; or the appropriation of any monies by budget, grant or otherwise by any element or entity of the local, State or Federal government. The terms "lobbying" or "lobbying activities" shall not include:
 - (1) Persons engaged in drafting legislation, rules, regulations or rates, advising clients and rendering opinions on proposed legislation, rules, regulations or rates, where such professional services are not otherwise connected with legislative or executive action on such local, State or Federal legislation, or local, State or Federal administrative action on such rules, regulations or rates;
 - (2) Newspapers and other periodicals and radio and television stations, and owners and employees thereof, provided that their activities in connection with proposed legislation, rules, regulations or rates are limited to the publication or broadcast of news items, editorials or other comment, or paid advertisements;
 - (3) Persons who participate as witnesses, attorneys or other representatives in public rule making or rate making proceedings of New York State or any political subdivision thereof and/or any Federal agency, with respect to all participation by such persons which part of the public record thereof and all preparation by such persons for such participation;

- (4) Persons who attempt to influence New York State or any political subdivision thereof or a Federal agency in an adjudicatory proceeding, as defined by section one hundred of the New York State Administrative Procedure Act;
- (5) Persons who prepare or submit a response to a request for information or comments by the New York State Legislature, the Governor, or a New York State agency or a committee or officer of the New York State Legislature or a New York State agency or by a legislative or executive body or officer of a New York State or any political subdivision thereof or a Federal commission or committee; and
- e. The term "New York State agency" shall mean any department, board, bureau, commission, division, office, council, committee or officer of New York State, whether permanent or temporary, or a public benefit corporation or public authority at least one of whose members is appointed by the governor, authorized by law to make rules or to make final decisions in adjudicatory proceedings but shall not include the New York State judicial branch or agencies created by interstate compact or international agreement.
- f. The term Federal government shall mean any officer or employee of the Executive or Legislative branches of the United States government, as those terms are defined in the Unites States Constitution and by Federal law, including, but not limited to, any department, board, bureau, commission, division, office, council, committee or officer of the United States, whether permanent or temporary, or a public benefit corporation or public benefit corporation or public authority authorized by law to make final decisions in adjudicating proceedings but shall not include the Federal judicial branch, or agencies created by international treaty.
- g. The term local government shall mean any officer or employee of the Executive or Legislative branches of any Town, Village or City government within the County of Erie as these entities are deemed to be municipal corporations of the State of New York.
- h. The term "legal activities", "advocacy" or "representation" shall mean any action, statement or activity entered into by any attorney, paralegal, legal assistant, or other persons engaged in the practice of law and for which they derive payment from a client, in this case, the County of Erie or its officers, officials or agents.

Section 4. Legislative Approval.

No special or outside counsel, or lobbyist, to be retained by Erie County for the purpose of lobbying or advocacy or legal representation or any legal matter, shall be retained until such person or persons has first responded to a request for proposal (RFP) initiated by Erie County, and the response has been evaluated and approved by the Erie County Legislature prior to such person or persons entering into any lobbying, lobbying activities, advocacy, legal representation or legal work upon behalf of Erie County.

Section 5. Annual Report.

At the end of each calendar year the County Executive shall prepare, issue and file with the Clerk of the Legislature an Annual Report detailing all the special or outside counsel, and/or lobbyists retained by Erie County in the preceding calendar year, identifying them, the nature and scope of their activities, and their cost to the taxpayers and citizens of Erie County therefore. Upon the request of any Erie County Legislator, such information shall also be provided immediately at any point during the year.

Section 6.

If any clause, sentence, phrase, paragraph or any part of this Local Law shall for any reason be finally adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Local Law but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or part thereof directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby declared to be the legislative intent that the remainder of this Local Law would have been adopted had any such provisions not been included.

Section 7.

This local law shall take effect immediately upon filing with the Secretary of State pursuant to Section 27 of the New York State Municipal Home Rule Law.

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, including approving orders of the State Comptroller, County Sewer District No. 4 of the County of Erie, New York, has heretofore been established and created on February 22, 1961 (the "District") to provide sewer services to the Villages of Depew and Lancaster and the Towns of Lancaster, West Seneca, Alden and Cheektowaga; and

WHEREAS, the Board of Managers of the District has duly directed that there be prepared a report and estimate of cost by the County Engineers (Erie County Department of Environment and Planning) relating to a proposed increase and improvement of the facilities of the District which report and estimate of cost have been approved by the Board of Managers of the District on September 15, 2004 and filed with the County Legislature pursuant to Section 268 of the County Law; and

WHEREAS, said report and estimate of cost describe a proposed increase and improvement of the facilities of the District, consisting of the reconstruction and/or replacement of approximately 7,765 linear feet of sewer, the installation of new Didion and Brunck Road sanitary sewers, the upgrading and/or replacement of pumping stations, and the reconstruction of the overflow retention facility, as more fully described in the report and estimate of cost hereinbefore referred to; and

WHEREAS, the maximum estimated cost of the aforesaid increase and improvement of the facilities of the District is \$4,850,000, to be assessed against a benefited area which consists of the entire area of the District, as well as the contracting communities including Erie County Sewer District No.1, West Seneca District No.6, Cheektowaga Sewer District No.

3, and Lancaster town sewer districts, all in accordance with their respective proportionate shares of equalized assessed value in the District; and

WHEREAS, pursuant to Section 258 of the County Law, as amended by Chapter 397 of the Laws of 1995, the consent of the State Comptroller is not required prior to the construction of said increase and improvement of facilities of the District because the cost thereof to the Typical Property (as defined in the County Law) does not exceed the Average Estimated Cost to the Typical Properties for similar types of expenditures, as computed by the State Comptroller and such cost is \$4.07 for the District, except that those portions of the District located in the Town of Lancaster outside of any village is \$9.67; and

WHEREAS, it is now desired to call a public hearing to consider said increase and improvement in accordance with the provisions of Section 254 of the County Law; NOW,

THEREFORE, BE IT

RESOLVED, BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. A meeting of the County Legislature of the County of Erie, New York, shall be held at 92 Franklin Street, 4th Floor, Buffalo, New York, in said County, on the 2nd day of December, 2004, at 1:30 o'clock P.M., Prevailing Time, for the purpose of conducting a public hearing upon the aforesaid proposed increase and improvement of facilities of Erie County Sewer District No .4 in said County and for such other action on the part of said County Legislature in relation thereto as may be required by law or proper in the premises.

<u>Section 2.</u> The notice of such public hearing shall be in substantially the following form, to-wit:

Section 3. The Clerk of said County Legislature is hereby authorized and directed to cause a copy of the Notice of Public Hearing as set forth in Section 2 hereof to be published once in the "Hamburg Sun" and in the "Front Page", the official newspapers of said County and in the "Lancaster Bee", not less than ten nor more than twenty days before the date set herein for said public hearing. The Clerk is hereby further authorized and directed to file a certified copy of the Notice of Public Hearing with the Comptroller of the State of New York on or about the date of the publication of the Notice of Public Hearing.

The increase and improvement of such facilities consisting of the reconstruction and/or replacement of approximately 7,765 linear feet of sewer, the installation of new Didion and Brunck Road sanitary sewers, the upgrading and/or replacement of pumping stations, and the reconstruction of the overflow retention facility, as more fully described in the report and estimate of cost prepared by the County Engineers (Erie County Department of Environment and Planning) which has been filed with the County Legislature and which has been approved by the Board of Managers of Erie County Sewer District No. 4 on September 15, 2004 (the "Report").

The maximum estimated cost of the aforesaid increase and improvement of the facilities of the District is \$4,850,000, to be assessed against a benefited area which consists of the entire area of the District, as well as the contracting communities including Erie County Sewer District No. 1, West Seneca District No. 6, Cheektowaga Sewer District No. 3, and Lancaster town sewer districts, all in accordance with their respective proportionate shares of equalized assessed value in the District.

The estimated hook-up fees for parcels in the District which are not already hooked up to the sewer system are \$2.00 for parcels with existing structures and \$202.00 for new structures, and the annual cost of such expenditures to the Typical Property (as defined in the County Law) is \$4.07 for the District, except that those portions of the District located in the Town of Lancaster outside of any village is \$9.67. The County Legislature has heretofore caused to be prepared and filed for public inspection with the Clerk of the Erie County Legislature, a detailed explanation of how such costs were computed, as incorporated in said report and estimate of cost prepared by the County Engineers (Erie County Department of Environment and Planning).

Sconiers' issued a decision pursuant to litigation brought be an aggrieved business which: 1) characterized the EC Department of Health's waiver process as not in line with New York State's Clean Indoor Air Act (CIAA) and the guidance provided by the NYS Department of Health on waivers; and 2) found that the County's waiver process, as drafted, was beyond the power granted by the NYS Legislature to the County under the CIAA, and

WHEREAS, Erie County appealed the order and argued the matter before the Appellate Division, 4th Department on September 13, 2004, and

WHEREAS, on October 1, 2004, the Appellate Division, 4th Department confirmed the holding of Justice Sconiers by ordering that the EC Health Department reformulate its waiver process after finding it irrational and beyond the power granted to it by the NYS Legislature, and

WHEREAS, there has not yet been a decision by the EC Department of Health or EC Attorney as to whether to appeal the matter to the NY Court of Appeals, and

WHEREAS, the Erie County Legislature does hereby urge both the EC Department of Health and EC Attorney to forgo any further appeals of Erie County's smoking waiver procedures, and

WHEREAS, the current state of economic distress across federal, state and local governments demands that we take greater notice of the fiscal condition of Erie County, and

WHEREAS, numerous published accounts have outlined significant budgetary shortfalls for fiscal year 2004 and even more severe projected shortfalls for 2005, and

WHEREAS, the regular release of budget monitoring reports and complete disclosure of reserve funds have not been met by the Division of Budget Management and Finance, and

WHEREAS, consistency and timeliness are particularly important when implementing budget monitoring, and

WHEREAS, reports for budget monitoring should include not only statements of cash flow, but an actual narrative and analysis including year end projections, and

WHEREAS, stable budgets are the result of careful planning and produce more stable and predictable tax levy and service delivery, and

WHEREAS, County Government should develop policies to guide the creation, maintenance, and use of a prudent level of financial resources to protect against reducing service levels or raising taxes and fees because of temporary revenue shortfalls or unpredicted one-time expenditures, and

WHEREAS, issuing debt commits the County's revenues several years into the future, and may limit the government's flexibility to respond to changing service priorities, revenue inflows, or cost structures, and

WHEREAS, in the past three years, Erie County Gross Direct Debt per Capita has more than doubled from \$298 in 2001 to \$611 for every man, woman, and child in the County as of June 12, 2004, and

WHEREAS, adherence to a debt policy helps ensure that debt is issued and managed prudently in order to maintain a sound fiscal position and protect credit quality, and

WHEREAS, County Government should adopt a policy on the maximum amount of debt and debt service that should be outstanding at any one time, and

WHEREAS, the proper policy limits may fall well below the legal or constitutional limits, and

WHEREAS, policies guiding the amount of debt that may be issued by the County would help ensure that outstanding and planned debt levels do not exceed an amount that can be supported by the existing and projected tax and revenue base, and

WHEREAS, the use of one-time revenues and spending down reserves without a long term budgetary plan in place jeopardizes the long-term financial health of the County, and

WHEREAS, by definition, one-time revenues cannot be relied on in future budget periods, and

WHEREAS, a policy on the use of one-time revenues provides guidance to minimize disruptive effects on services due to non-recurrence of these sources, and

WHEREAS, governmental budgets must take into account a longer view and include financial projections for future years in order to more accurately monitor their budgets,

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby recognize that long term fiscal stability in Erie County is vital to the success of this region and the taxpayers of this County, and be it further

RESOLVED, that this Honorable Body and the Erie County Comptroller will work together to develop clear policies promoting long term tax relief and budget stabilization, and

RESOLVED, that this Honorable Body wishes to implement a policy of using cash or pay-as-you-go funding, whenever possible, to pay for necessary county projects, and be it further

RESOLVED, such policies on debt level and capacity should be developed in accordance with an analysis of debt capacity including, but not limited to, current financial capacity, projected future capacity, statutory and constitutional limitations, and bond covenants, and be it further

RESOLVED, that budgetary policy guidelines be adopted where parameters for one-time revenues and allowable uses for those revenues be explicitly defined, with periodic review of the policy, and compliance with it, and be it further

RESOLVED, that the annual budget submission, beginning with the Fiscal Year 2005 proposed budget to be submitted in November 2004, shall include at least two additional years of budget projections beyond the proposed fiscal year budget to allow for long-term planning and budget tracking, and be it further

WHEREAS, Medicaid, a federal and state mandated program, has been and continues to be the single largest expense in the Erie County Budget, and

WHEREAS, New York State's Medicaid program is the most extensive and expensive in the nation, and

WHEREAS, one-half of the funding for Medicaid is provided by the federal government, and

WHEREAS, one-quarter of the funding for Medicaid is provided by the state government, and

WHEREAS, the remaining one-quarter of funding for Medicaid is passed on Erie County, and

WHEREAS, this funding structure separates New York State from nearly every other state in United States by handing county governments an impossible fiscal burden, and

WHEREAS, for 2005, early estimates place Erie County's Medicaid burden at over \$200 million, and

WHEREAS, there have been several announcements by the County Executive in recent days of possible widespread service cuts including cultural funding, sheriff's road patrol, snowplowing, libraries and even social programs unless Medicaid relief can be secured, and

WHEREAS, it will be impossible for Erie County to balance its 2005 Budget without an unprecedented county property tax increase, or an unshared sales tax increase, or an across-the-board termination of unmandated services or a combination of the above, and

WHEREAS, there have been numerous proposals made with regard to Medicaid relief for counties, and

WHEREAS, one proposal to assist Erie County with its Medicaid burden would be for New York State to designate Erie County as a pilot program and assume Erie County's 2005 Medicaid expenses in exchange for Erie County agreeing to give New York State 1% of Erie County's 4% sales, and

WHEREAS, such an agreement would result in a savings of approximately \$75 million to Erie County which would be used to maintain the County services cited for possible cuts, cultural funding, sheriff's road patrol, snowplowing, libraries and social programs, and

WHEREAS, due to the severity of this situation and the potential time required to craft such a proposal, the sponsors of this resolution would request that the New York State Legislature consider this proposal immediately in order that it could become a reality for Erie County in 2005,

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby endorse the proposal that New York State designate Erie County as a pilot program and assume Erie County's 2005 Medicaid expenses in exchange for Erie County agreeing to give New York State 1% of Erie County's 4% sales tax, and be it further

WHEREAS, 1% of that 4% is kept exclusively by Erie County for funding in its budget minus a 1/8 distribution to the NFTA, and

WHEREAS, in 2003, the 1% of the Sales Tax kept exclusively by Erie County resulted in \$119 million to the County minus \$14.8 million contributed by the County to the NFTA or \$104.2 million, and

WHEREAS, there have been numerous proposals made by various government officials with regard to Medicaid relief, and

WHEREAS, one such proposal put forth was for New York State to assume the entire amount of Erie County's Medicaid expenses with Erie County agreeing to forego the County's exclusive 1% sales tax revenue, and

WHEREAS, such an agreement would result in a savings of \$21.8 million to Erie County which should be used and divided pursuant to the parameters and percentages of the existing 3% sales tax distribution formula, and

WHEREAS, due to the severity of this situation and the potential time required to craft such a proposal, the sponsors of this resolution would request immediate consideration and passage of this resolution,

NOW, THEREFORE, BE IT
