## COUNTY OF ERIE LOCAL LAW NO. \_\_\_\_\_- 2004 LOCAL LAW INTRO NO. \_\_\_\_\_- 2004

A LOCAL LAW amending, Local Law No. 1-1959, as amended, constituting the Erie County Charter Section 1802 thereof; and the Erie County Administrative Code Section 18.02 Sub. f with respect to the duty of the Erie County Executive to submit a budget and capital program to the Erie County Legislature.

BE IT ENACTED BY THE ERIE COUNTY LEGISLATURE AS FOLLOWS:

Section 1. Short Title. This Local Law shall be known as the "Erie County Budget Disclosure Act" and shall amend, as hereinafter specified Section 1802 of the Erie County Charter and Section 18.02 Sub. f of the Erie County Administrative Code.

Section 2. Legislative Intent. The Erie County Legislature hereby determines that the people of Erie County have the right to know the contents of and fiscal implication of the County's adopted annual budget, the County Executive's tentative budget for the ensuing fiscal year, the County Executive's budget projections for the two subsequent years, and the extent of the capital program to ensure fiscal accountability.

Section 3. Provisions. The following provisions shall be inserted to amend the Erie County Charter and the Administrative Code to the extent of the provisions hereinafter set forth.

- (A) In 2004, and in all subsequent years, the County Executive shall submit to the County Legislature a tentative budget for the 2000 Fiscal Year and subsequent fiscal years along with the simultaneous submission of the County Executive's financial forecast for the next two (2) years, together with a capital spending program for the next six (6) fiscal years, in addition to an accompanying message.
- (B) Upon the enactment of this Local Law, the County Executive shall submit his tentative budget (including both the operation and maintenance budget, and the capital budget) for the ensuing year, along with a two-year budget forecast for the two (2) succeeding fiscal years, and a capital program for the next six (6) fiscal years along with the County Executive's accompanying message to the County Legislature on or before the 15<sup>th</sup> day of October in the year 2005 and in all subsequent years.

Section 4. Publication. The Clerk of the Erie County Legislature is hereby authorized and directed to cause a copy of the foregoing Local Law to be published in the County's official newspapers.

Section 5. Effective Date. This Local Law shall take effect immediately upon the filing with the Secretary of State pursuant to Section 27 of the New York State Municipal Home Rule Law.

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, including approving orders of the State Comptroller, County Sewer District No.3 of the County of Erie, New York, has heretofore been established and created on April 9, 1963 (the "District") to provide sewer services to the Village of Orchard Park, the north and central portions of the Town of Orchard Park, the northeast portion of the Town of Hamburg and the southerly portion of the Town of West Seneca, and

WHEREAS, the Erie County-Southtowns Sewage Treatment Agency (the "Southtowns Agency") has heretofore been created pursuant to an inter-municipal agreement dated December 30, 1974, as amended, (the "Southtowns Agreement") for the purpose of establishment, construction, operation, and maintenance of the Southtowns Advanced Wastewater Treatment Facility (the "Southtowns Treatment Facility") for the benefit of Erie County Sewer District No.3, the Hamburg Master Sewer District, Amsdell Heights, Locksley Park, Cloverbank, Benz and Taylor Road Sewer Districts being Sewer District Nos. 21, 7, 10, 5, 4,8, and 11 of the Town of Hamburg, Wanakah Sewer District No.3, Mount Vernon Sewer, District No.2, and the Village of Hamburg; and

WHEREAS, pursuant to the Southtowns Agreement the County, acting for and on behalf of Erie County Sewer District No.3, was responsible for financing the total project costs for the Southtowns Treatment Facility; and

WHEREAS, in accordance with its responsibilities to maintain the Southtowns Treatment Facility pursuant to the Southtowns Agreement, the Southtowns Agency has duly directed that there be prepared a report and estimate of cost by the County Engineers (Erie County Department of Environment and Planning) relating to a proposed increase and improvement of the facilities of the District which report and estimate of 'cost have been approved by the Board of Managers of the Southtowns Sewer Treatment Agency on April 29, 2004 and filed with the County Legislature pursuant to Section 268 of the County Law; and WHEREAS, said report and estimate of cost describe a proposed increase and improvement of the facilities of the District(Southtowns Sewage Treatment Agency), consisting of the reconstruction and/or rehabilitation of approximately 20,000 feet of sanitary sewer and the upgrading of sewage pumping stations, as more fully described in the report and estimate of cost hereinbefore referred to; and

WHEREAS, the maximum estimated cost of the aforesaid increase and improvement of the facilities of the District is \$9,000,000, to be apportioned in accordance with the Southtowns Agreement among (i) Erie County Sewer District No.3, (ii) the Town of Hamburg on behalf of the Hamburg Master Sewer District, Amsdell Heights, Locksley Park, Cloverbank, Benz and Taylor Road Sewer Districts being Sewer District Nos. 21, 7, 10,5,4,8, and 11 of the Town of Hamburg, (iii) Wanakah Sewer District No.3, (iv) Mount Vernon Sewer District No.2, and (v) the Village of Hamburg; each in accordance with their respective proportionate shares of equivalent dwelling units in their service areas, as determined pursuant to the Southtowns Agreement; and

WHEREAS, pursuant to Section 258 of the County Law, as amended by Chapter 397 of the Laws of 1995, the consent of the State Comptroller is not required prior to the construction of said increase and improvement of facilities of the District because the cost thereof to the Typical Property (as defined in the County Law) does not exceed the Average Estimated Cost to the Typical Properties for similar types of expenditures, as computed by the State Comptroller; and

WHEREAS, it is now desired to call a public hearing to consider said increase and improvement in accordance with the provisions of Section 254 of the County Law; NOW, THEREFORE, BE IT

The expenditures for such additional increase and improvement of facilities will not cause additional costs for property owners in the District for hook-up fees, and the annual cost of such expenditures to the Typical Property (as defined in the County Law) is \$10.72. The County Legislature has heretofore caused to be prepared and filed for public inspection with the Clerk of the Erie County Legislature, a detailed explanation of how such costs were computed, as incorporated in said report and estimate of cost prepared by the County Engineers (Erie County Department of Environment and Planning).

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, a report of the Erie County Sewer Agency dated September 15, 2004 and a resolution of the Erie County Sewer District No.3 Board of Managers dated September 15, 2004, an extension of Sewer District No. 3 of the County of Erie, New York has been proposed; and

WHEREAS, a map and plan have been duly prepared by the County Engineers (Erie County Department of Environment and Planning) relating to such extension of the Erie County Sewer District No.3, which map and plan have been filed with the County Legislature pursuant to Section 254 of the County Law; and

WHEREAS, pursuant to Section 258 of the County Law, the consent of the State Comptroller is not required prior to the extension of said Erie County Sewer District No.3 because such extension is not to be financed by the issuance of bonds, notes, certificates or other evidences of indebtedness of the County; and

No additional capital improvements are proposed to be, constructed and no additional capital costs are to be incurred by or on behalf of the Erie County Sewer District No.3 with respect to the extension of the boundaries of such District and the acquisition of the existing sanitary sewer facilities, but future annual charges will be apportioned between real property in the District in accordance with their respective proportionate shares in accordance applicable flat charges, hook-up charges and charges based on units, assessed value and footage, specified in the District's Benefit and User Charge formulas, as such formulas currently exist and as amended from time to time.

Hook up fees are currently \$200 per home for a lateral hook-up, \$200 per home for inspections associated with subdivisions and a \$2 permit fee at the time of connection. The annual cost of the extension to the typical property is \$262.

WHEREAS, the County of Erie is desirous of having access to a professional consultant with expertise in analyzing, assessing and developing accounts receivable management programs that are designed to maximize revenue opportunities.

RESOLVED, that the County Executive is hereby authorized to enter into an agreement for an amount not to exceed \$ 120,000 at \$185 per billable hour plus per diem expenses not to exceed \$50, with Lawrence W. WHEREAS, a Special Grand Jury was empanelled on October 20, 2003, to examine alleged abuses in the Department of Public Works, and

WHEREAS, the Special Grand Jury recently released their report titled, "Matters Relating to the Practices and Behaviors of the Highway Division of the Erie County Department of Public Works", and

WHEREAS, it is stated in Section IX of the Special Grand Jury Report that:

"The employee who received the photographs [of alleged wrongdoings] gave them to a county legislator, explaining that he did not believe that the executive branch would fairly investigate the matter. In early August, 2001, the legislator gave the photographs to the DPW commissioner and to the Deputy Commissioner for Highways. The commissioner told the deputy commissioner to look into it" (p. 71-72)

WHEREAS, The Special Grand Jury Report recommends in relation to the alleged abuses and the involvement of the Legislature that:

"Under Article II § 201(h) of the Charter, the legislature has the authority to investigate matters it deems to be in the best interest of the County. The Grand Jury recommends that the legislature formalize a procedure for following up on allegations of misconduct that come to the attention of any legislator. A legislator who refers a matter to a department in the executive branch should insist on a written report detailing how the matter was addressed. That report should then be forwarded to the appropriate legislative committee. If no report is received, the legislature should consider conducting its own investigation. The legislature is not disciplinary arm of the executive branch. Nevertheless, it must deal with matters that come to its attention" (p.112-113)

WHEREAS, while the report did not find any abuses on the part of legislators, it did conclude that protocols should be implemented,

NOW, THEREFORE, BE IT

RESOLVED, that the Chairman of the Erie County Legislature will refer this issue to an existing committee or create an Ad Hoc Committee to formulate a policy for the proper handling of allegations.

4. Item Page -2004 (Comm. 22E-37) COUNTY EXECUTIVE

WHEREAS, on July 1, 1999, this Legislature enacted a resolution (Comm. 12E-14) approving of a lease (hereinafter "Lease") with 43 Court Street Realty Company (hereinafter "43 Court St.") for 31,040 square feet of office space located at 43 Court Street in Buffalo for use by the Department of Social Services (hereinafter "Social Services"); and

WHEREAS, the Lease was signed by the County Executive and dated as of October 20th 1999; and

WHEREAS, the term of the Lease is five years, commencing on July 13, 2000 and expiring on July 12, 2005; and

WHEREAS, as a condition of the Lease, 43 Court St. has spent approximately \$1 million in renovating the office space to the satisfaction of Social Services; and

WHEREAS, Social Services desires to renew the Lease for an additional five year term, commencing on July 13, 2005 and expiring on July 12, 2010; and

WHEREAS, in consideration for the County's renewal of the Lease at this time, 43 Court St. has agreed that the rental rate in year one of the renewal term will remain at the same rate of the preceding year of the original term (\$12 per square foot), and the rent will increase by only \$.50 per square foot in years two and three of the renewal term (\$12.50 per square foot) and \$1.00 per square foot in years four and five of the renewal term (\$13.00 per square foot); and

WHEREAS, as further consideration for the County's renewal of the Lease at this time, 43 Court St. will provide an upgrade allowance for improvements to the Social Services office space and will make several improvements to the public areas, including increased security, passenger elevator upgrades and renovation of the lobby; and

WHEREAS, Social Services would prefer to renew the Lease rather than move elsewhere due to the inconvenience and added cost such a move would generate.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to renew the Lease with 43 Court St., and execute all documents related thereto, for 31,040 square feet of office space located at 43 Court Street in Buffalo for use by Social Services; and be it further

RESOLVED, that such renewal shall commence on July 13, 2005 and expire on July 12, 2010; and the rental rate shall be \$12 per square foot in year one of the renewal, \$12.50 per square foot in years two and three of the renewal, and \$13 per square foot in years four and five of the renewal; and be it further

RESOLVED, that the terms and conditions of the original Lease, dated October 20, 1999, shall remain substantially the same for the renewal period, unless the County Attorney deems that the interests of the County will best be served by amending or modifying such terms and conditions; and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the County Executive, Commissioner of Social Services, Comptroller, Director of Budget, Management and Finance and County Attorney.

WHEREAS, for several years, the Law Department has leased office space at 69 Delaware Avenue, Suite 300 in Buffalo (hereinafter "69 Delaware"); and

WHEREAS, the latest lease, which was dated January 1, 1995, was extended for a two-year term in 1998 and since 2000, the lease has been extended on a year-to-year basis; and

WHEREAS, the County Attorney now desires to renew the lease at 69 Delaware for a threeyear term, commencing January 1, 2005 and expiring on December 31, 2007; and

WHEREAS, as an incentive for the Law Department's renewal of the lease for a three-year term, 69 Delaware Avenue Associates LLC, the landlord of 69 Delaware (hereinafter "Landlord") has agreed to keep the rental rate the same for 2005 as what was charged in 2004, increase the rental rates in 2006 and again in 2007 by only \$500 per month for each year, limit the "additional rent" adjustments for increased property taxes and operating expenses to \$2,000 per year, and perform a certain amount of painting and carpet cleaning each year; and

WHEREAS, the Law Department shall also be given the option, but not the obligation, to renew the lease for an additional two-year term (January 1, 2008 to December 31, 2009), upon ninety (90) days written notice to the Landlord prior to the expiration of the first renewal term, and the rent will be increased in 2008 and again in 2009 by only \$500 per month for each year; and

WHEREAS, the Law Department has researched the lease rates of other suitable office sites and has determined that these rates are equal to or greater than the rates that will be charged by the Landlord in the lease renewal; and

WHEREAS, the Law Department would prefer to renew the Lease rather than move elsewhere due to the inconvenience and added cost that such a move would generate.

NOW, THEREFORE, BE IT

RESOLVED, That the County Executive is hereby authorized to renew the lease with the landlord for Suite 300 at 69 Delaware, and execute all documents related thereto, for 12,600 square feet of office space for use by the law Department for a cost of \$13.33 per square foot; and be it further

RESOLVED, that such renewal shall commence on January 1, 2005 and expire on December 31, 2007; and the rental rate shall be \$14,000 per month in year one of the renewal (2005), \$14,500 per month in year two of the renewal (2006), and \$15,000 per month in year three of the renewal (2007); and be it further

RESOLVED, that at the County Executive's/Law Department's option, the lease may be renewed for an additional two-year term, commencing January 1, 2008 and expiring on December 31, 2009, upon ninety (90) days written notice to the Landlord prior to the expiration of the first renewal term, and the rental rate shall be \$15,500 per month in 2008 and \$16,000 per month in 2009; and be it further

RESOLVED, that as further conditions of the lease renewal, the "additional rent" adjustments for increased property taxes and operating expenses shall not exceed \$2,000 per year, and a certain amount of painting and carpet cleaning shall be performed by the Landlord during each year of the lease renewal, and be it further

RESOLVED, that the other terms and conditions of the original lease, dated January 1, 1995, shall remain substantially the same for the renewal period, unless the County Attorney deems that the interests of the County will best be served by amending or modifying such terms and conditions; and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the County Executive, Comptroller, Director of Budget, Management and Finance, and County Attorney. (4-0) Legislator Wroblewski absent.

Re: Establishing a Formal Policy for Whistleblowing Concerning Erie County Government.

A RESOLUTION SUBMITTED BY LEGISLATOR MARINELLI WHEREAS, federal, state, county, city, town and village governments and other governmental entities and agencies across the county maintain formal, written provisions, rules and regulations concerning their employees and officers and providing for the promotion of, and protection for those persons who report wrongdoing, malfeasance, and violations of the public trust by government employees or officers, and

WHEREAS, Section 75-b of the New York State Civil Service Law guarantees protection to public employees regarding their employment, stating: "A public employer shall not dismiss or take other disciplinary or other adverse personnel action against a public employee regarding the employee's employment because the employee discloses to a governmental body information: (i) regarding a violation of a law, rule or regulation which violation creates and presents a substantial and specific danger to the public health or safety; or (ii) which the employee reasonably believes to be true and reasonably believes constitutes an improper governmental action. "Improper governmental action" shall mean any action by a public employer or employee, or an agent of such employer or employee, which is undertaken in the performance of such agent's official duties, whether or not such action is within the scope of his employment, and which is in violation of any federal, state or local law, rule or regulation," and

WHEREAS, despite and notwithstanding this state law, the County of Erie maintains no provision to protect "whistleblowing" or "whistleblowers" in the Erie County Charter, Administrative Code, nor Erie County Personnel Policies and Procedures, and

WHEREAS, given recent scandals in County government, including in particular, the matter involving the Erie County Department of Public Works (Aurora Barn matter), in which County employees in competitive-class, civil service positions who informed County managers and at least one County Legislator of wrongdoing and malfeasance on the part of other County employees in managerial-confidential positions were later inappropriately and illegally subjected to harassment, demotion, transfer and suffered the loss of overtime and other benefits, there is an urgent need to rectify and correct this glaring omission, and

WHEREAS, for instance, in the DPW Aurora scandal, a Special Grand Jury found that "... It remains that certain employees were harmed by an abuse of the disciplinary process. Some of these employees tried to speak out about questionable practices long before there were any audits, internal reviews, or complaints by other officials. Instead of being applauded as good public servants, they were rewarded with lost wages, punitive transfers, haranguing, immeasurable anxiety, and litigation costs" and

WHEREAS, the Special Grand Jury made two major recommendations regarding whistleblowing, with the first recommendation requiring action by the Executive: "The administration should develop a formalized procedure to examine allegations of serious misconduct in the county workforce. There should at least be a memorandum or writing reflecting when a commissioner of higher official first learns of an allegation, and who is to look into it. The matter should not be considered closed until a report is written stating the steps taken and the conclusion reached or why a conclusion could not be reached. An executive level official should then determine what, if anything else should be done and should consider whether the matter should be referred to a police agency" and

WHEREAS, the Grand Jury's second recommendation applied to the Legislature: "The Legislature should formalize a procedure for following up on allegations of misconduct that come to the attention of any legislator. A legislator who refers a matter to a department in the executive branch should insist on a written report detailing how the matter was addressed. That report should then be forwarded to the appropriate legislative committee. If no report is received, the Legislature should consider conducting its own investigation. The Legislature is not a disciplinary arm of the executive branch. Nevertheless, it must deal with matters that come to its attention"

## NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature reaffirms to all County employees, managers and elected officials their rights and responsibilities under Section 75-b of the Civil Service Law, and be it further

RESOLVED, that, in the wake of, and as a direct response to the Department of Public Works Aurora Barn matter, the Erie County Legislature does hereby express and announce its support for the establishment of a formal whistleblower policy for Erie County government within, and as an addendum to the Erie County Personnel Policies and Procedures and which applies to all county employees, and be it further

RESOLVED, that this new whistleblower policy is attached, and shall immediately, upon passage by this Honorable Body, become Section 25 of Chapter X of Erie County Personnel Policies and Procedures, and the Commissioner of Personnel is directed to announce the new policy in writing, through interoffice mail and electronic mail, and through posting on the Erie County website, of this new whistleblower policy, and be it further

RESOLVED, that the Erie County Legislature reiterates that the Erie County Comptroller currently holds responsibility and oversight for monitoring "waste, abuse, employee or vendor misconduct" and encourages County employees or other persons who become aware of misconduct, malfeasance or violations of the public trust to consider reporting such to the Office of the Comptroller, and be it further

RESOLVED, that the Erie County Legislature, cognizant of the findings and recommendations of the Special Grand Jury in the DPW Aurora matter, directs the Executive Branch to report to the Legislature with a written report detailing any new whistleblower procedures and policies established by the administration for all County departments and employees as well as any other non-County persons as a result of the Aurora matter and the Special Grand Jury's report, and be it further

RESOLVED, that the Erie County Legislature, cognizant of the findings and recommendations of the Special Grand Jury in the DPW Aurora matter, does hereby address and comply with the Grand Jury's recommendation regarding whistleblower or any other complaints that come to the attention of a Legislator through the establishment of a policy whereby any complaints

that come to the attention of a Legislator shall be entered into the public record through clock-in at the Legislature, and sent to the Legislature's Government Affairs Committee for discussion and appropriate action and follow-up by the administration and/or Comptroller or Legislature, and be it further

RESOLVED, that certified copies of this resolution be transmitted to the County Executive, County Attorney, Commissioner of Personnel.

WHEREAS, these funds will allow the Sheriff's Office to purchase equipment and supplies to maintain a Satellite Domestic Violence Office in the Town of Evans and provide necessary training and equipment to the Sheriff's Deputies and Domestic Violence Advocates currently assigned to the Sheriff's Domestic Violence Unit.

RESOLVED, that the County is hereby authorized to enter into a contract with the State of New York, Office of Children and Family Services and is authorized to accept funding in the amount of \$34,860, and be it further
