**WHEREAS,** as a result of Batavia Downs ceasing racing operations, approximately \$338,779 remained in the Batavia Downs Designated Purse Account at the time the assets of the Genesee Monroe Racing Association were sold to the Regional OTB, and

**WHEREAS,** this money consisted of the horsemen's share of money wagered at Batavia Downs in the meet ending in October, 1997 and not paid out during the meet, as well as money due the horsemen's purses from off-track wagering which occurred prior to the sale of Batavia Downs to the Western Region OTB in July, 1998, and

WHEREAS, this money should have been used to supplement the horsemen's purses at the next Batavia Downs meet, scheduled for the summer of 1998. However, instead of racing in the summer of 1998, due to the closure of Batavia Downs, the horsemen raced at Buffalo Raceway, and

WHEREAS, as a separate racing association, Buffalo Raceway was unable to supplement its new summer of 1998 races with the money earned for the horsemen at Batavia Downs, and

WHEREAS, a recent ruling by the New York State Racing and Wagering Board indicated that under current law the money in the Batavia Downs purse account could not be used to supplement purses at Buffalo Raceway, thus depriving Western New York horsemen of their share of the commissions earned at Batavia Downs during the summer of 1997, and

**WHEREAS**, legislation (S.7188/A.10300) has been introduced in the New York State Legislature by Senator Dale Volker and Assembly Richard Smith to address the inequity by ensuring the distribution of the purse money earned at Batavia Downs to Western New York horsemen,

## NOW, THEREFORE, BE IT

**RESOLVED**, the Erie County Legislature does hereby support the fair distribution of purse money earned on pari-mutuel wagering and off-track betting attributable to pre-July 1, 1998 operations at Batavia Downs so that the funds can benefit Western New York Horsemen, and be it further **RESOLVED,** that the Erie County Legislature believes that provisions of New York State Racing, Pari-Mutuel Wagering and Breeding Law unfairly punish Western New York horsemen due to the unique circumstances involving the cessation of operations at Batavia Downs, and be it further

**RESOLVED,** that the Erie County Legislature does hereby strongly support S.7188/A.10300 as a means of addressing this matter in a fair and equitable manner, and be it further

**RESOLVED**, that the Erie County Legislature does hereby call upon the New York State Legislature to approve and the Governor to sign into law S.7188/A.10300, and be it further
